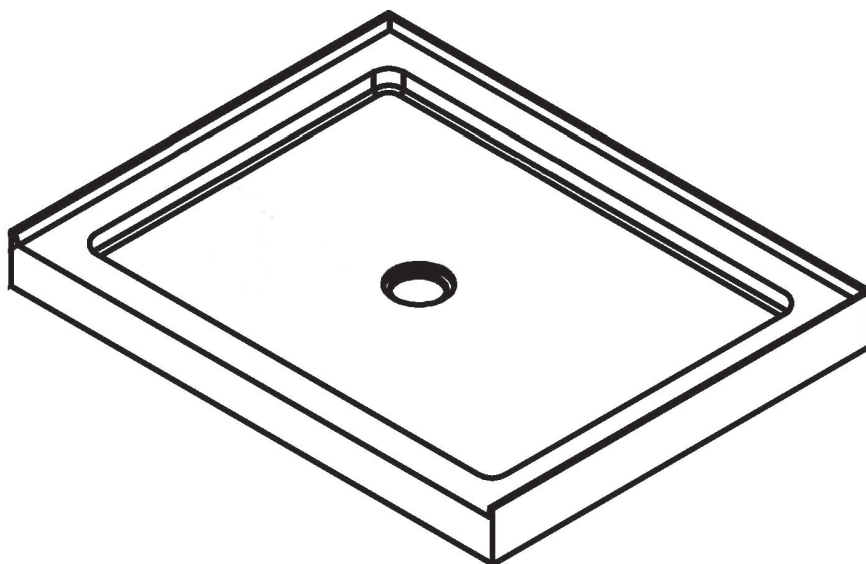

- Two people are recommended to install the shower base.
- Read all installation instructions prior to starting the installation.
- We recommend allowing the shower base to reach room temperature before starting the installation process.
- Prevent exposure to moisture during the installation process.
- Please avoid installing the shower base on open floor joists.
- Before installation, carefully examine the shower base to ensure it has not sustained any damage during shipping.
- The framing studs need to be vertically straight and at right angles to the subfloor, which will serve as the foundation for the base.
- Make sure all wood studs and supports are properly installed.
- The dimensions of the opening should be at least 1/8 inch (3mm) larger than the dimensions indicated on the specification sheet.
- Please note that the dimensions provided are for reference only. It is crucial to accurately measure the shower tray dimensions, including the overall size, base thickness, and location of the drain, before beginning the installation process.
- We recommend only cutting a hole in the subfloor once you have received the shower base.
- It is advised to avoid stepping on the shower base until the installation process is complete.
- The floor system should possess adequate reinforcement and support to sustain a load of 50 pounds per square foot.
- The shower base needs to be supported solely by the floor, carrying its weight without relying on any other elements. **DO NOT** let the skirt or the flange support the weight of the shower base.
- These products must be installed by a fully insured and licensed plumber only. Before commencing the installation process, carefully inspect all boxes and packages for any shipping damages.
- Once you've opened all the boxes, read the instructions thoroughly, and ensure all the necessary components are included in the package. If there is damage, **DO NOT INSTALL THE PRODUCT!**

- Installation of any product by anyone other than a fully insured and licensed plumber shall void the limited warranty.
- Building and plumbing codes may vary state-to-state. We are not responsible for any local code compliance for this product.
- Streamline shall not be held liable for any and all incidental damage or flood caused due to the use of this product.

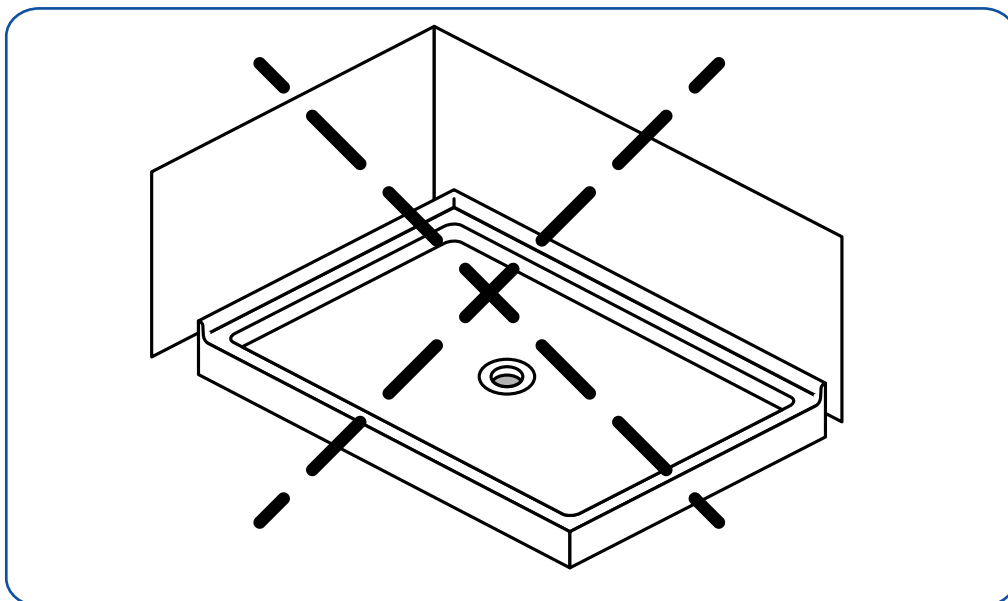


3. Installation Instructions

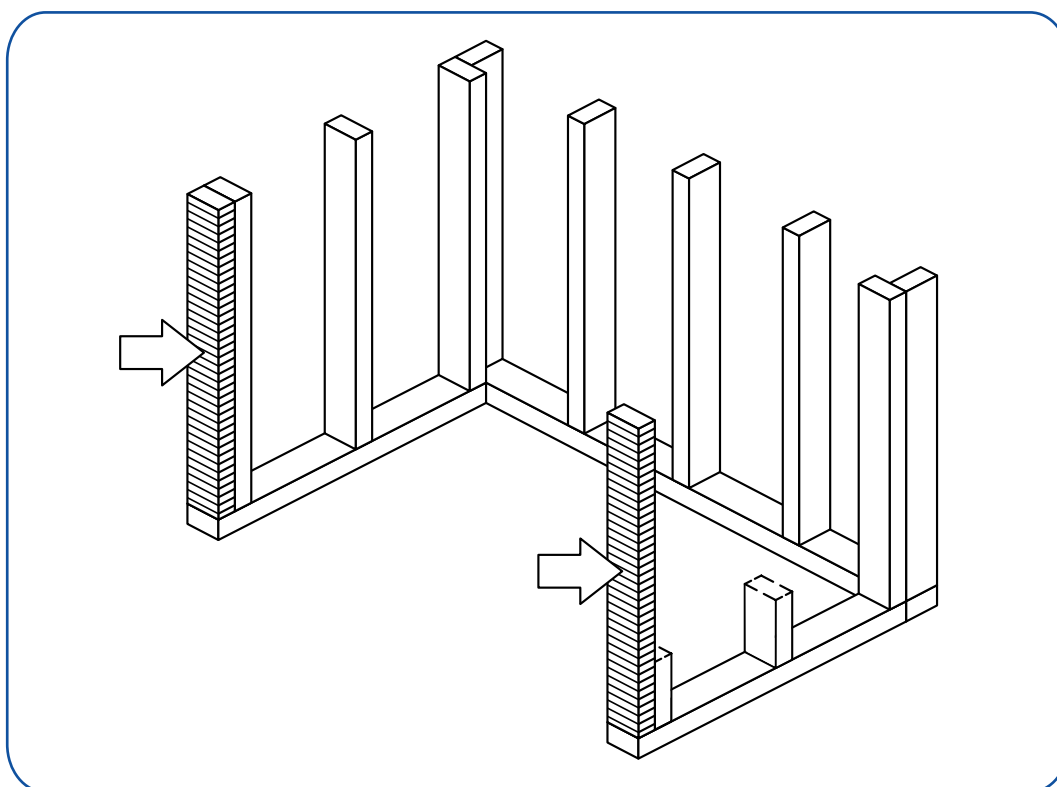
1. Ensure the framing studs are vertically straight, right-angled to the floor, and level.



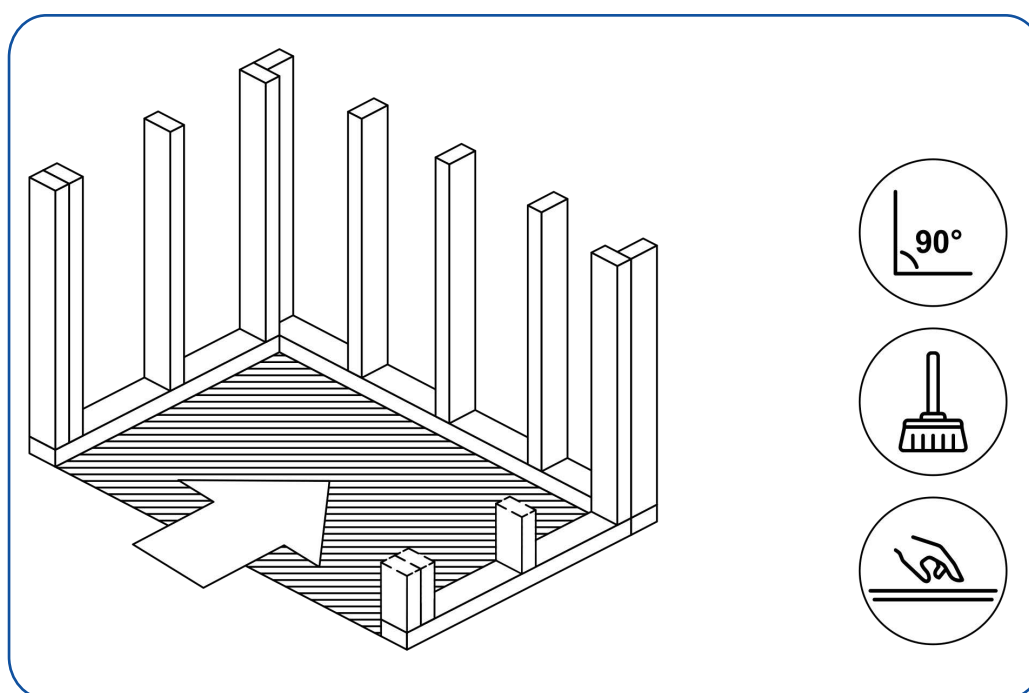
2. To ensure proper installation and stability, the shower base should be installed directly against the studs and not against the wall. This will provide a secure and sturdy base for the shower and prevent any shifting or movement over time.



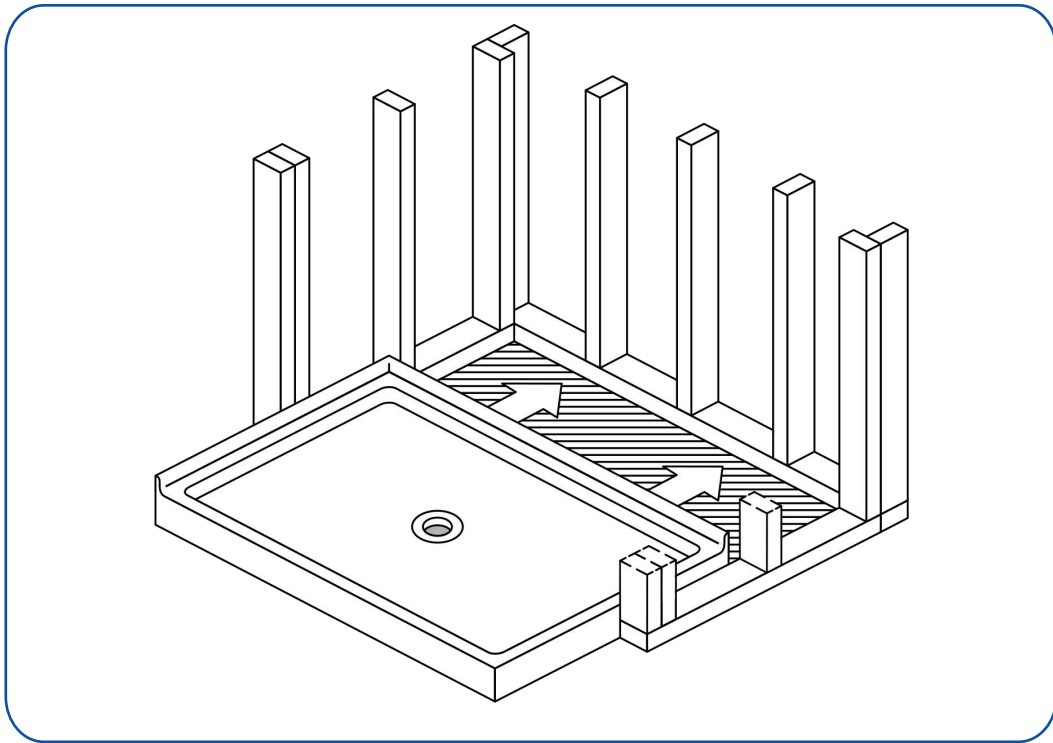
3. **[OPTIONAL]** For enhanced support and ease of shower door installation, it is recommended to include an extra 2"x4" stud in the wall structure.



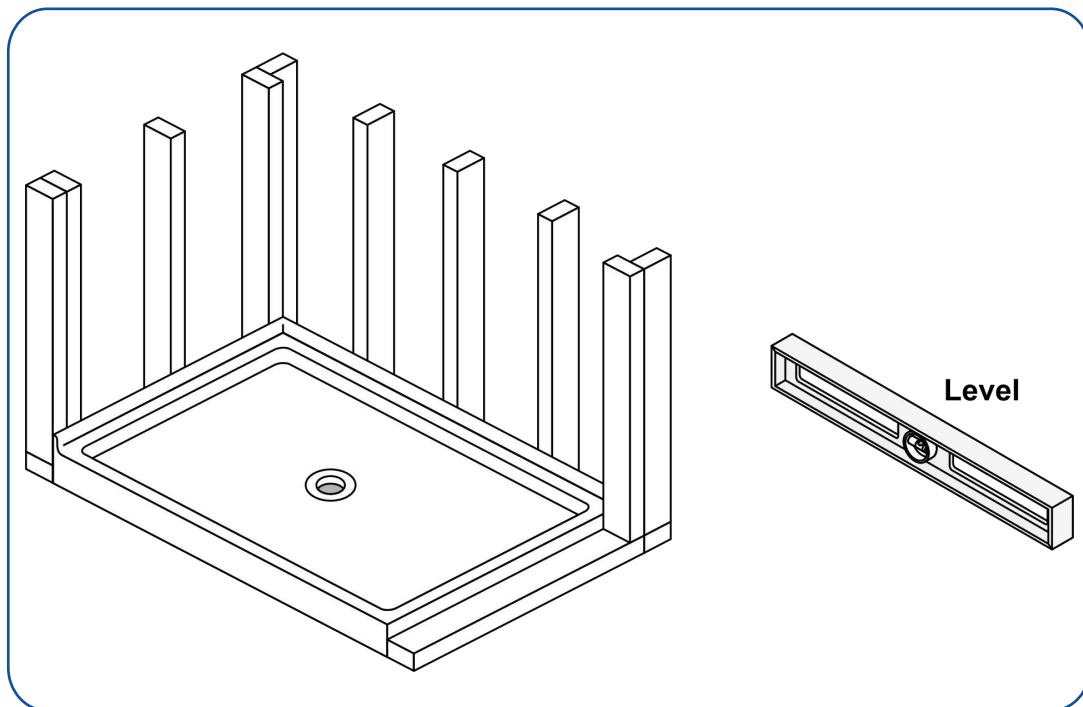
4. It is essential that the floor is level, clean, and smooth.



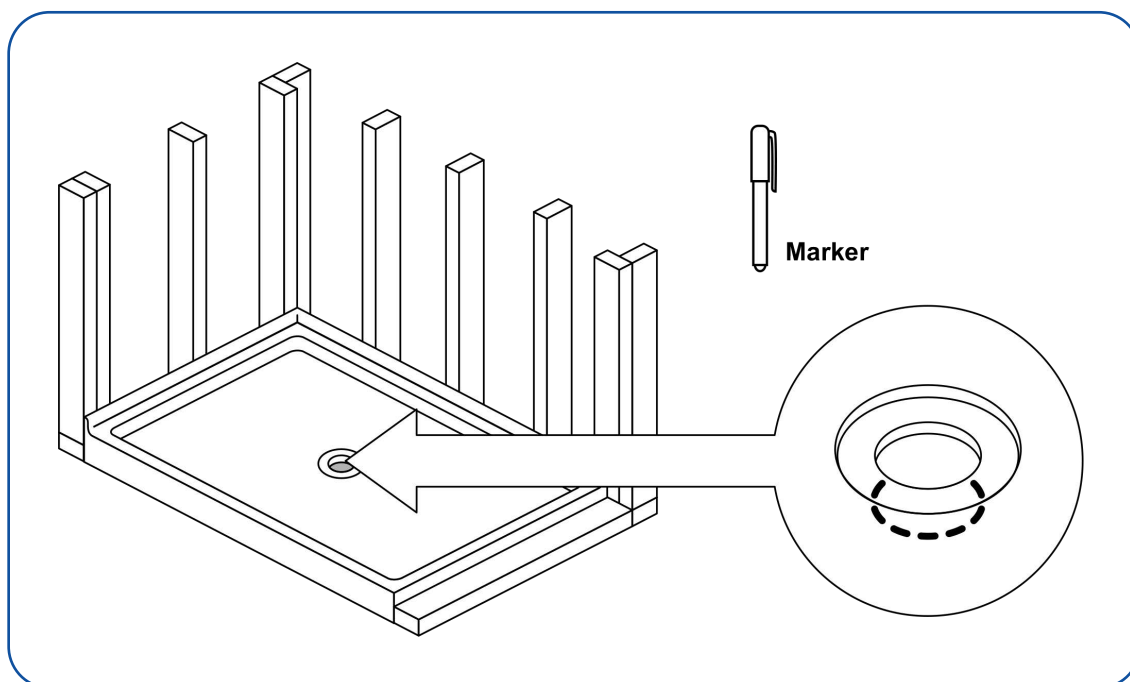
5. Place the shower base against the intended installation area.



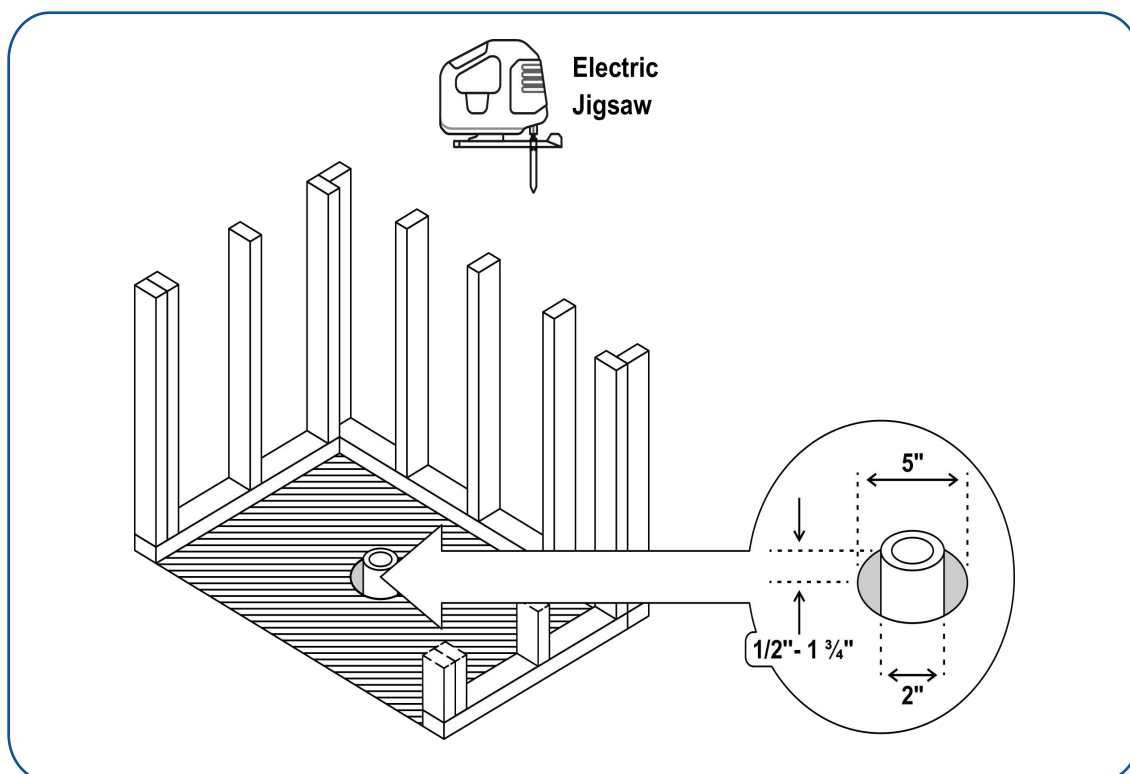
6. Use a leveling tool to confirm that the shower base is leveled on all four sides.



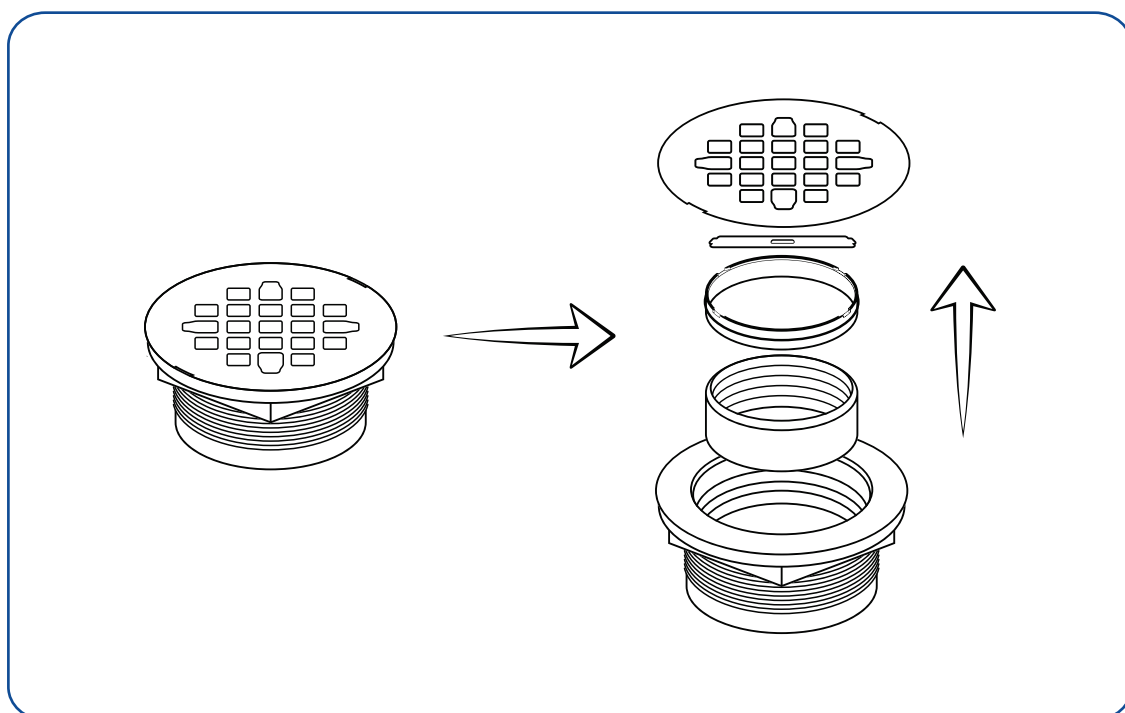
7. Mark the drain location.



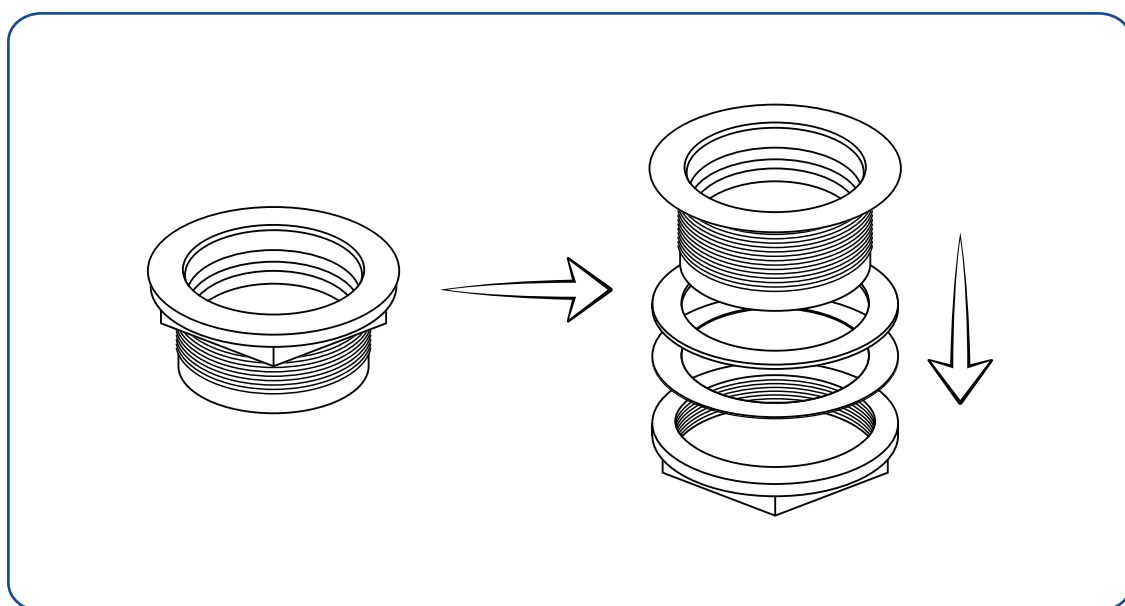
8. Make an opening in the sub-floor that is 5" x 5" and ensure that the 2" waste pipe is located centrally in the cutout and is raised at least 1/2" to 1 3/4" above the floor. Refer to the product specification sheet for the drain rough-in.



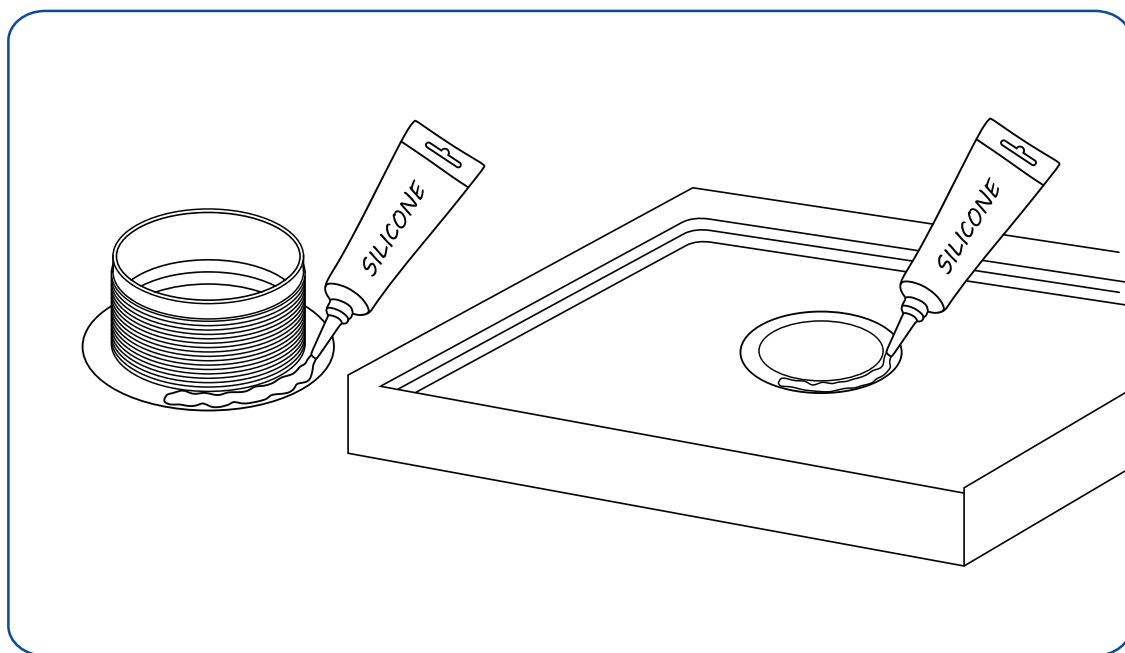
9. Remove the stainless-steel strainer, compression nut, compression wrench, and rubber compression gasket from the drain.



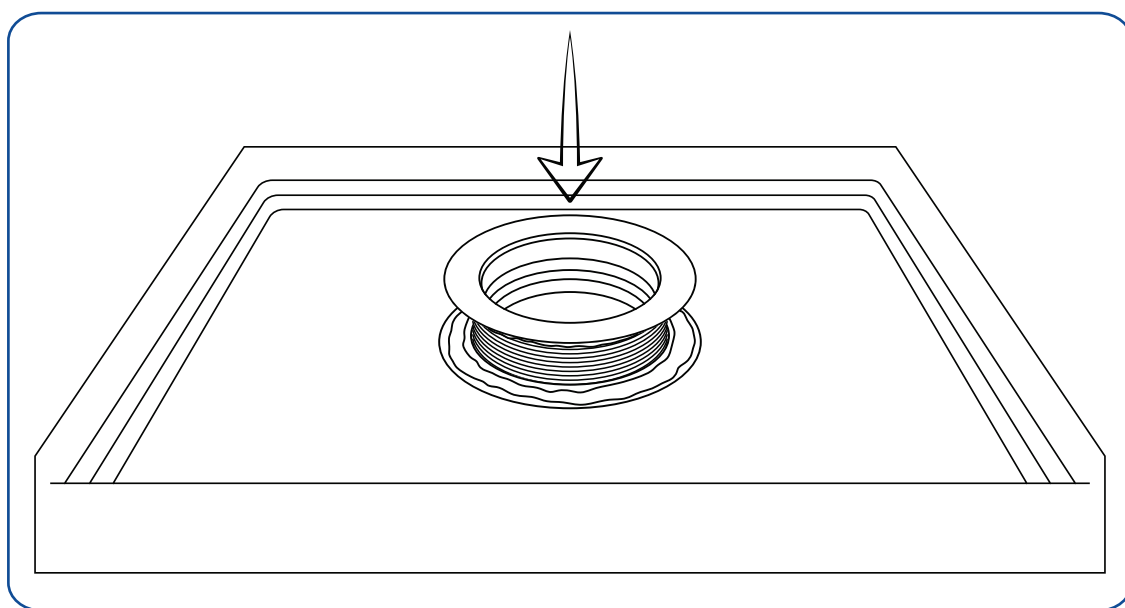
10. Take apart the locking nut and remove the rubber washer and the friction



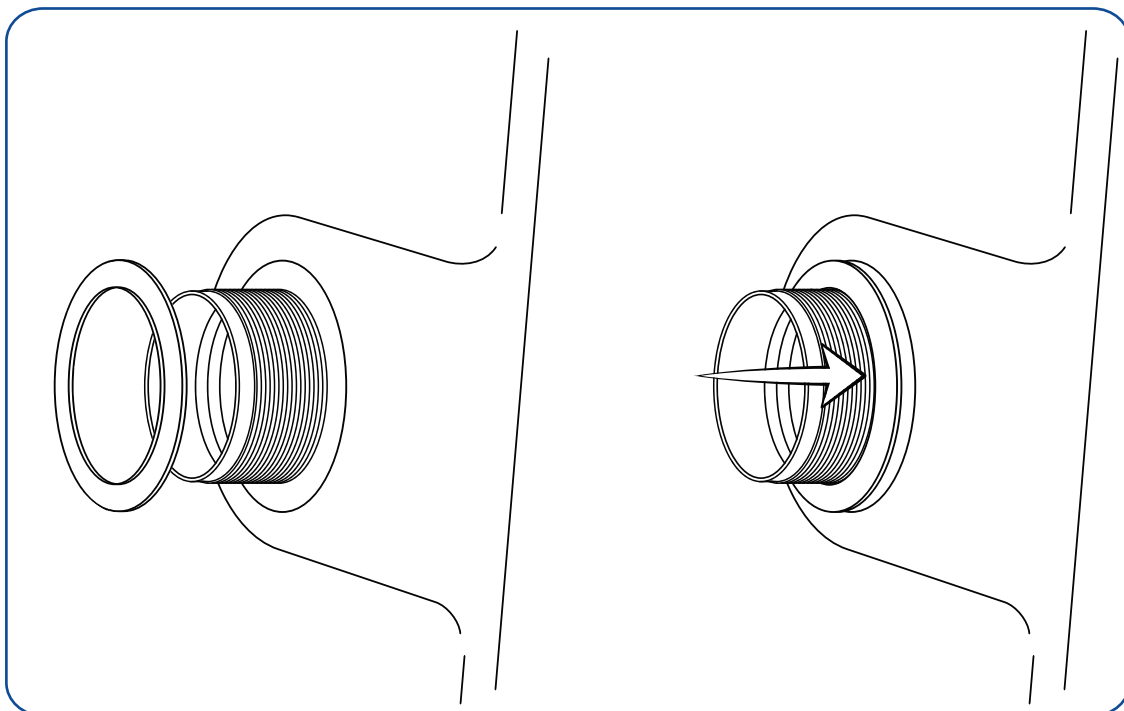
11. Take the drain body and run a continuous line of silicone along the underside lip. Additionally, apply a line of silicone around the drain hole in the shower base.



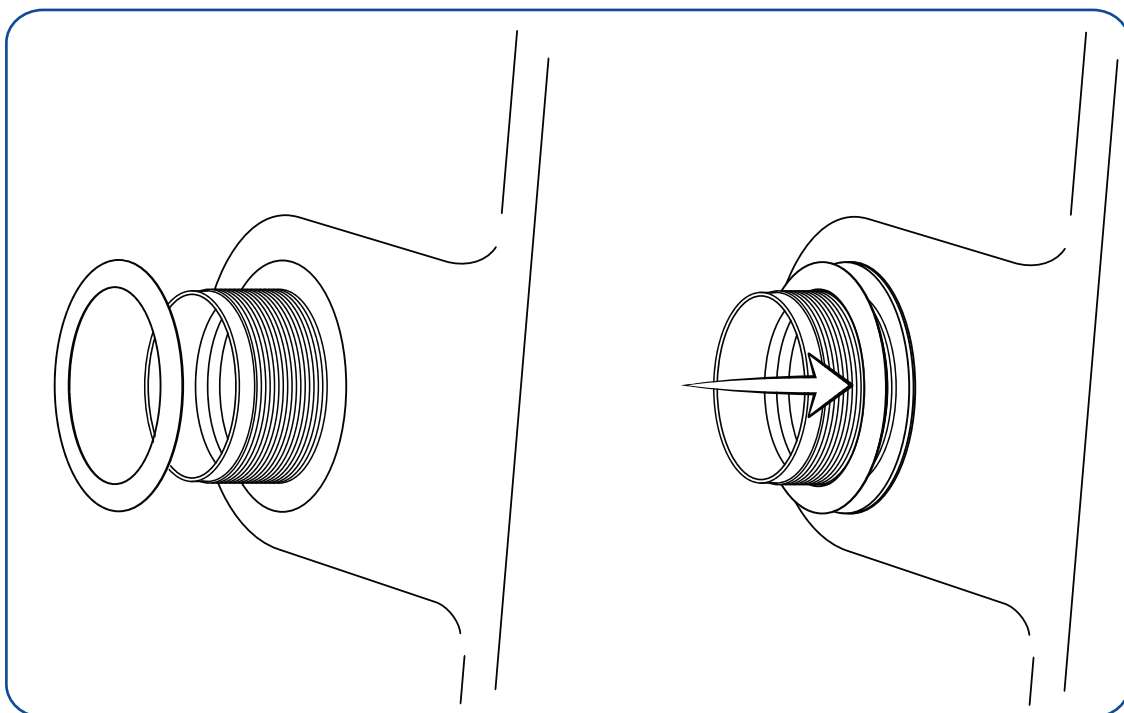
12. Insert the drain body into the drain hole of the shower base, pressing down as firmly as possible without twisting.



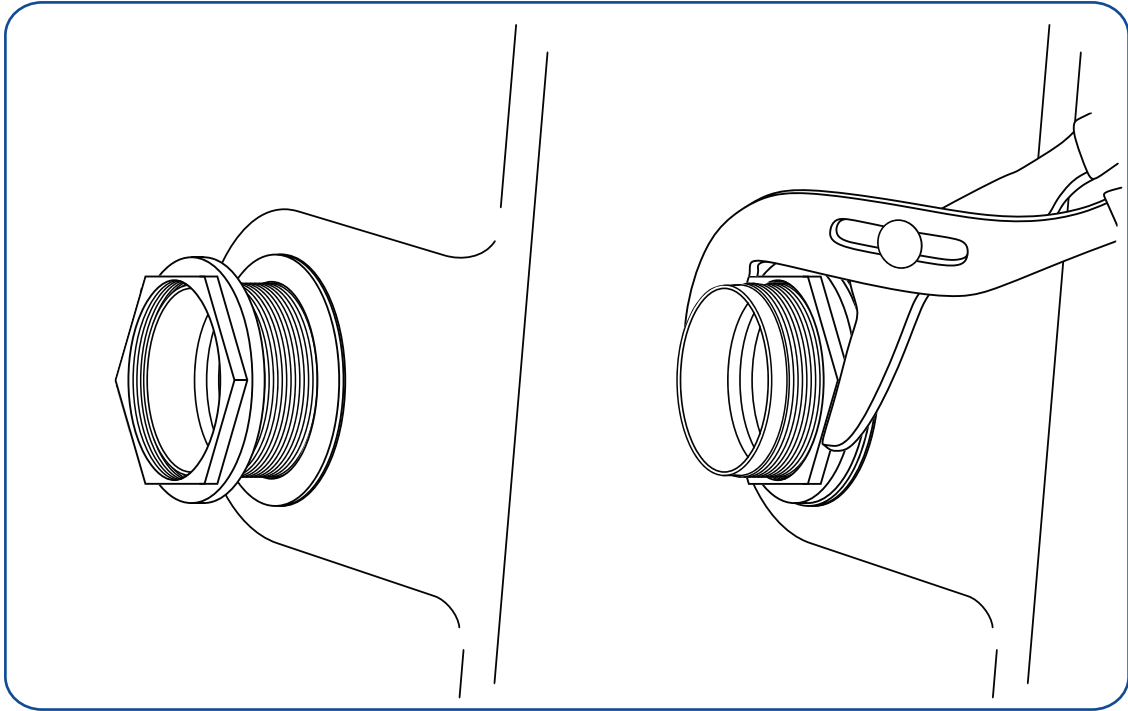
13. Attach the rubber washer to the drain body from the underside of the shower base.



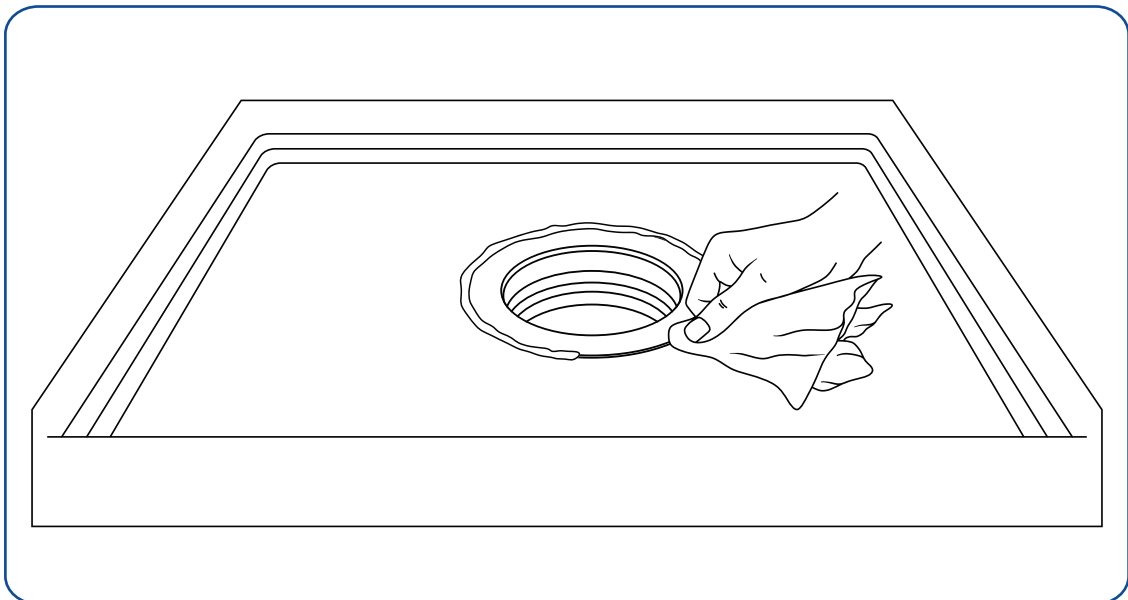
14. Next, attach the friction washer to the drain body.



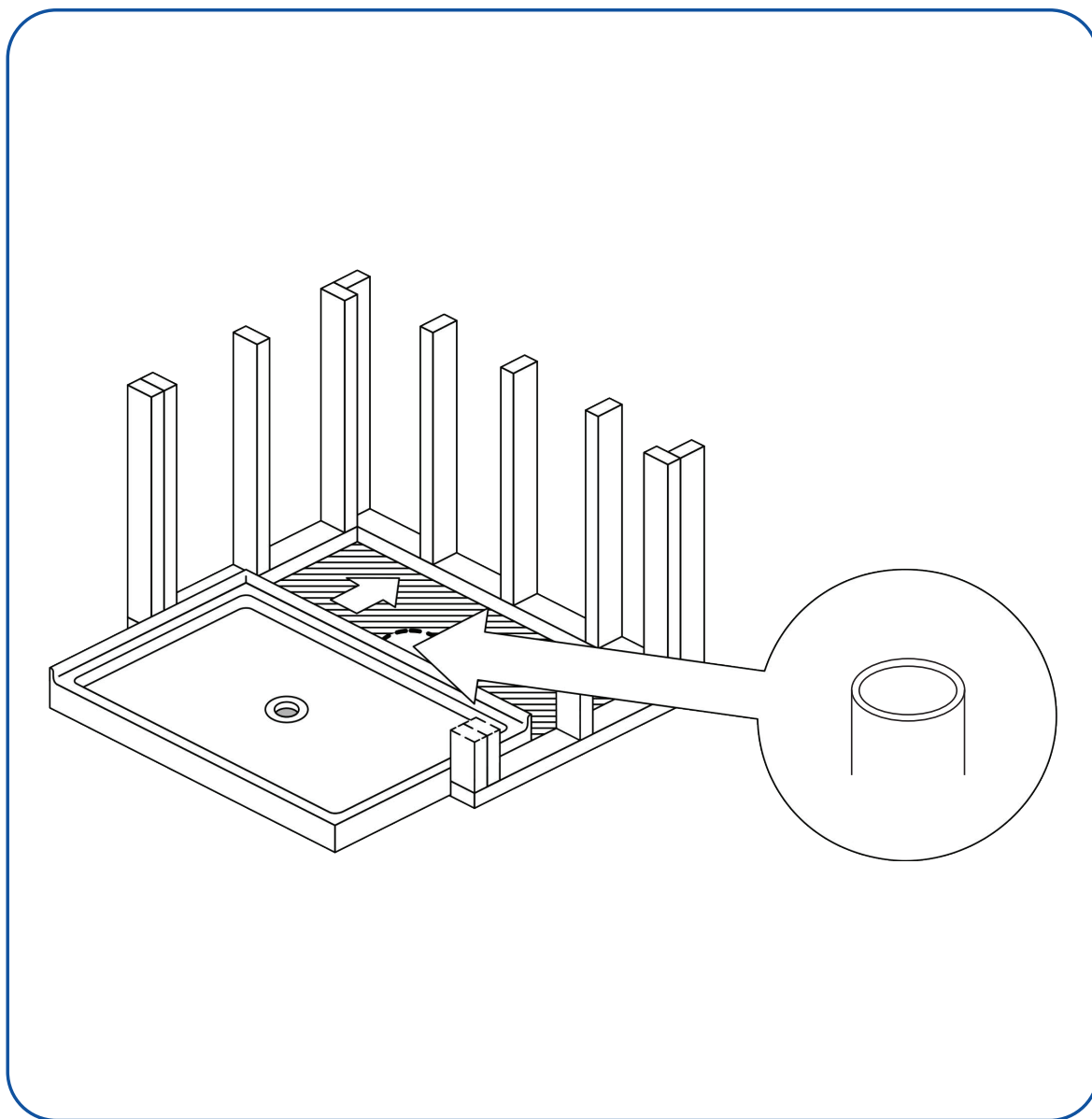
15. Secure the drain by threading the locking nut onto it and then tightening it with adjustable pliers or by hand.



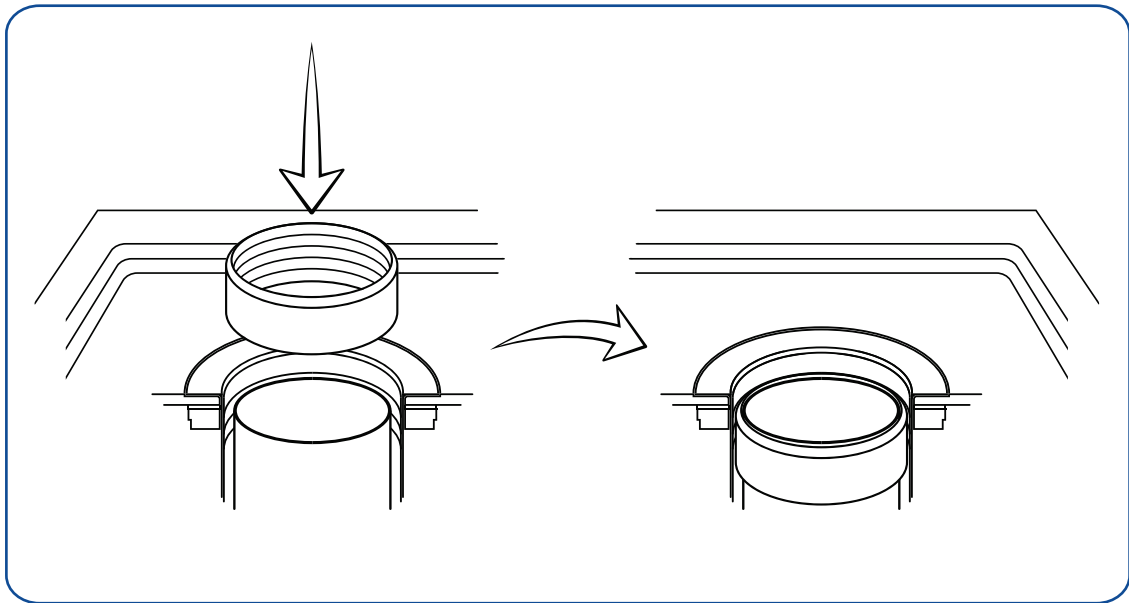
16. Remove any surplus silicone from the drain.



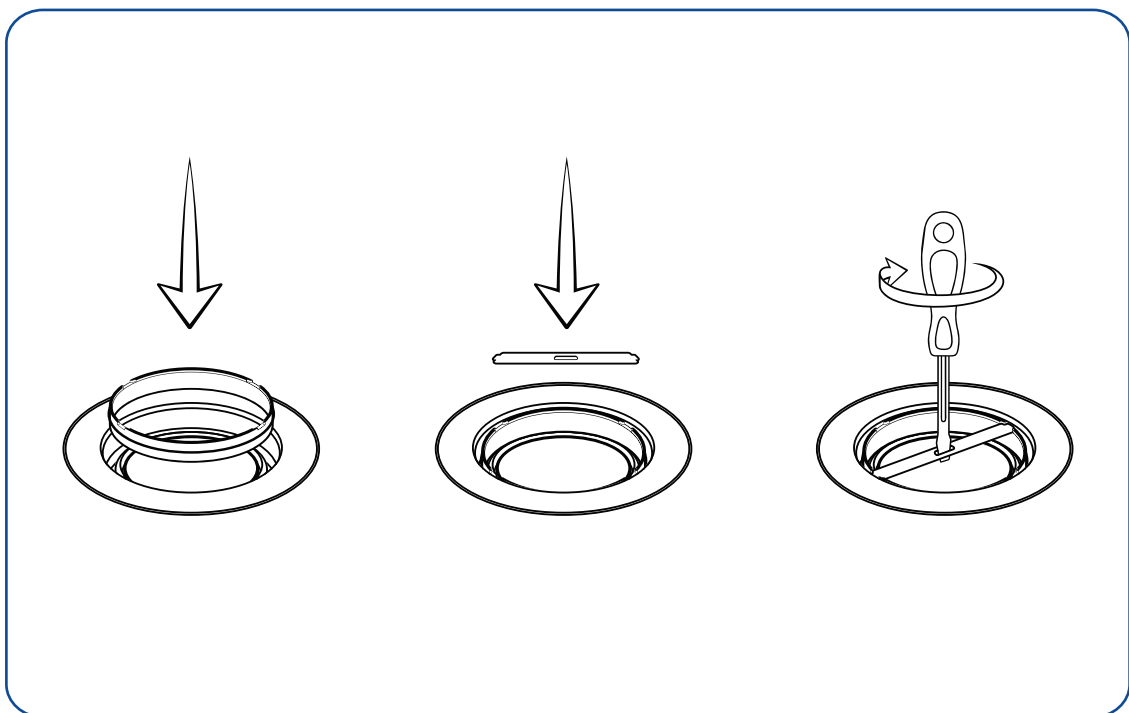
17. Carefully position the shower base back into the installation location, ensuring that the location of the drainpipe aligns with the actual location of the shower base drain.



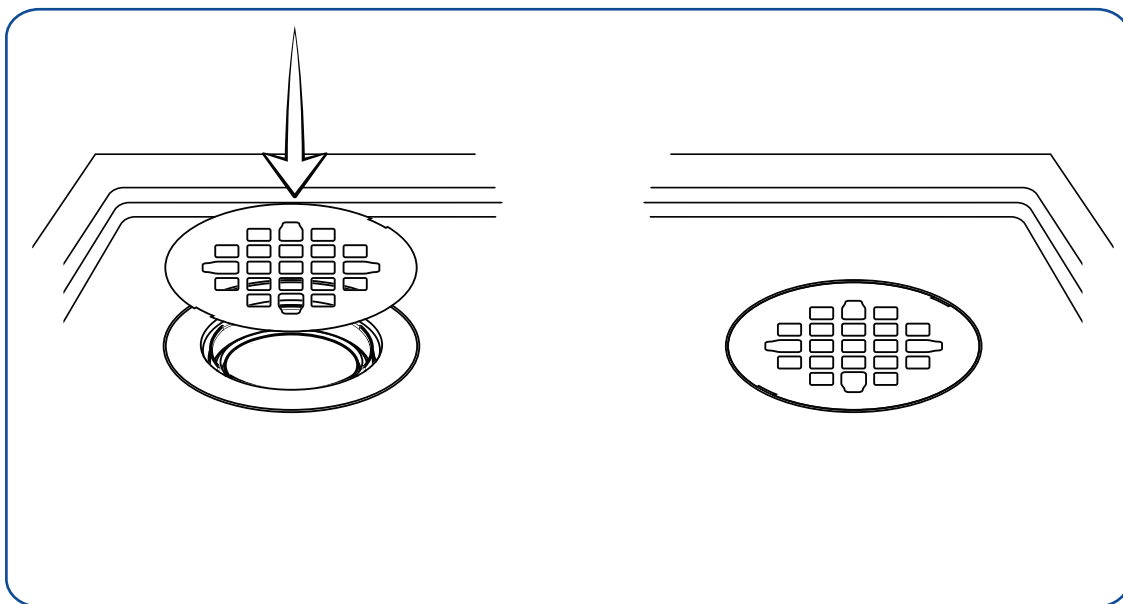
18. Position the rubber compression gasket over the drainpipe that protrudes through the drain, ensuring the beveled side faces upward. Apply firm pressure to the gasket until it reaches the bottom of the drain.



19. Insert the compression nut into the drain body and utilize the provided compression wrench and a screwdriver to tighten it. Turn clockwise to secure it in place.

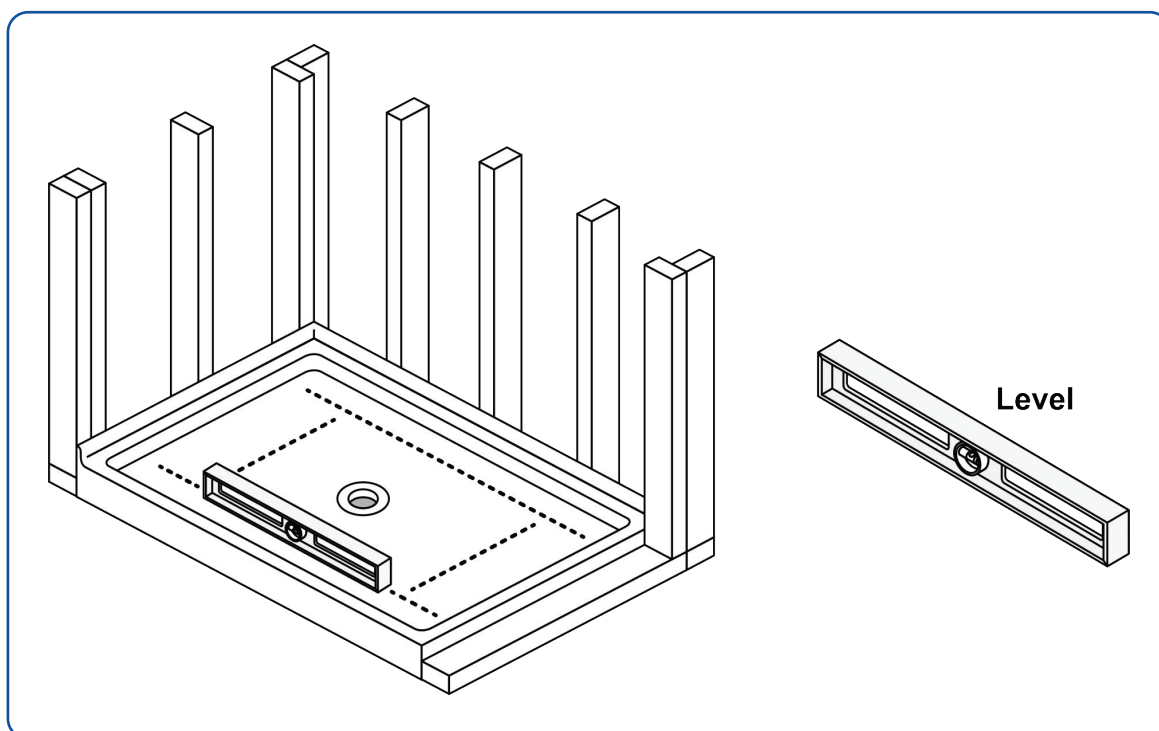


20. Align the stainless-steel cover with the grooves on the drain and firmly press it into place to ensure a secure fit.

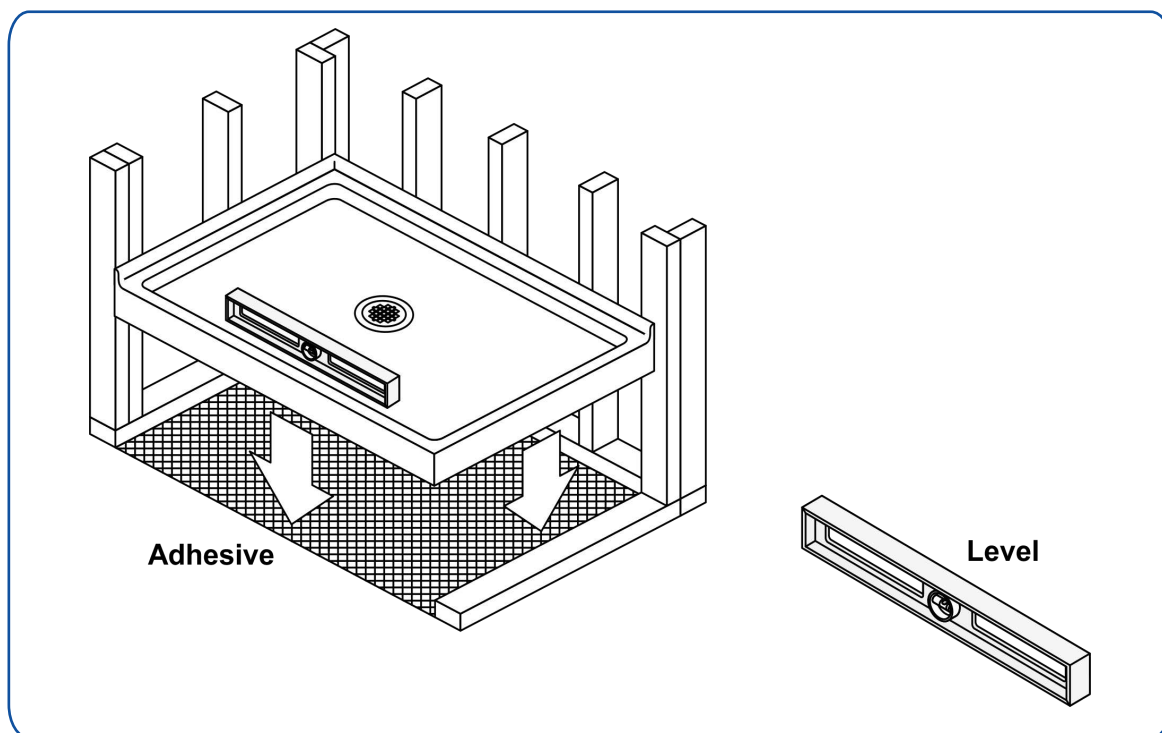


21. Once the drain is completely installed, verify proper drainage, and inspect for potential leaks.

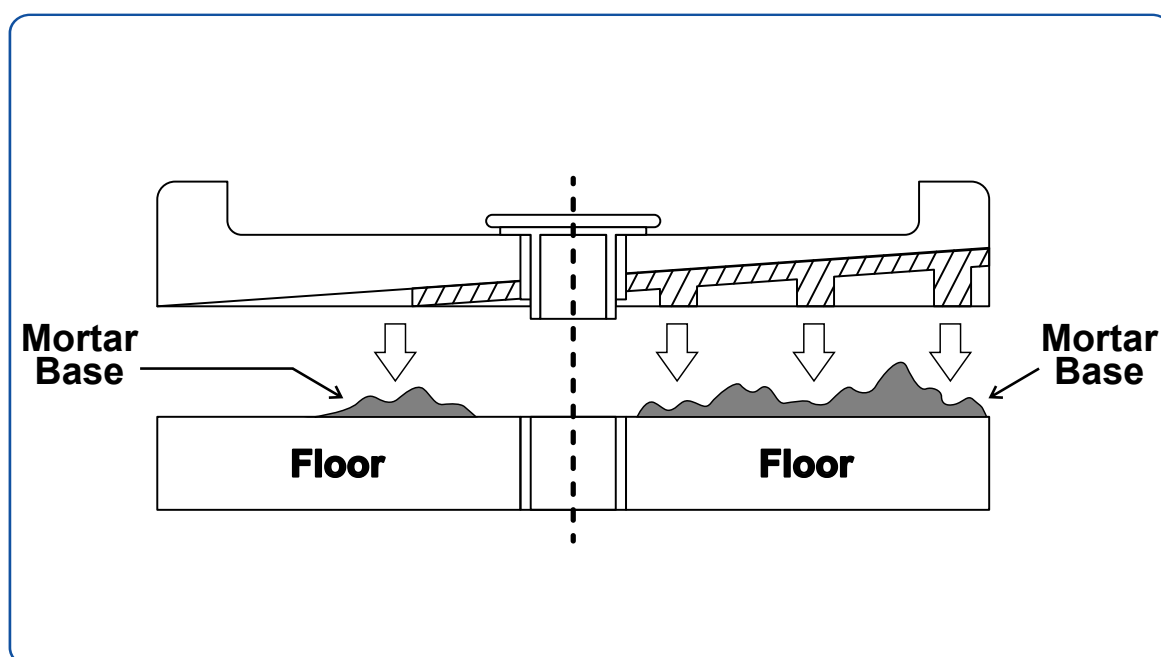
22. Re-check to make sure that the shower base is level.



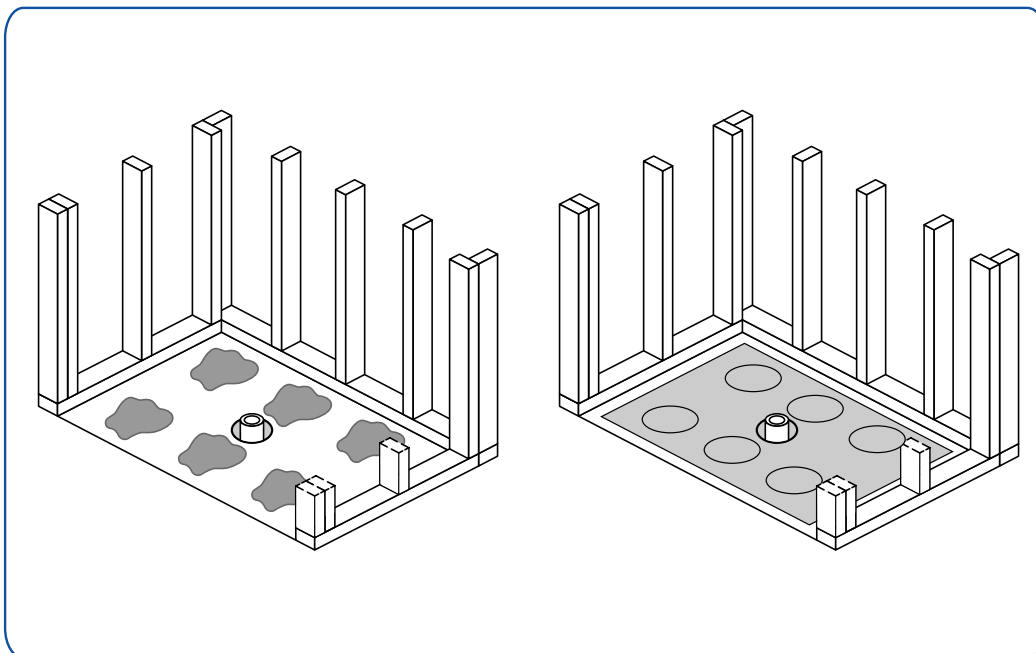
23. If the shower base is level, apply adhesive on the floor. Place the shower base in adhesive and adjust it until it is level. Place the shower base and ensure full contact with the floor, apply pressure, and level the base.



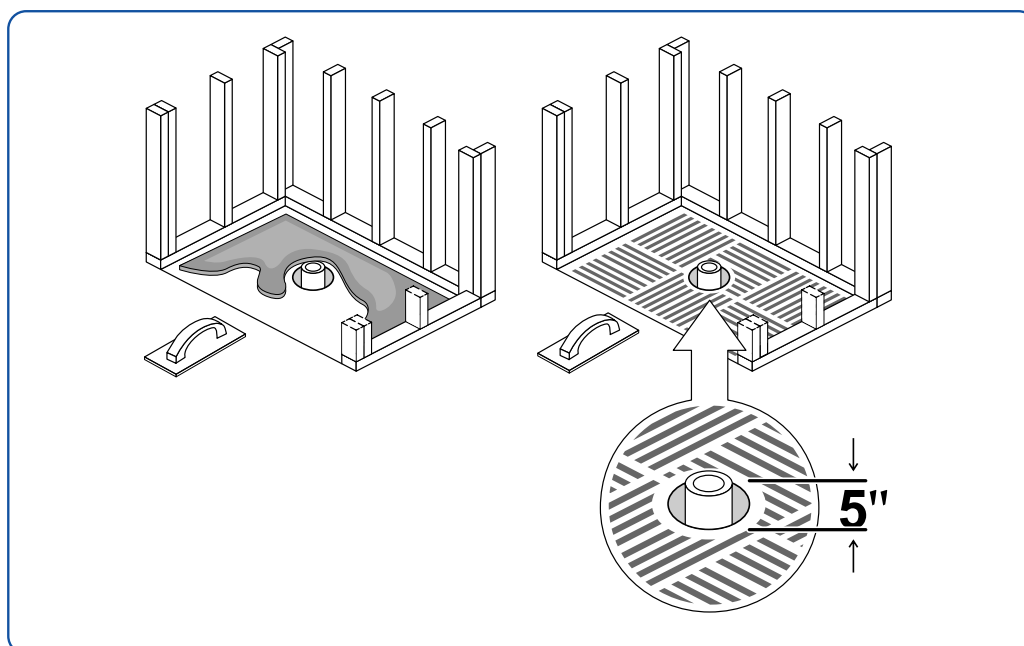
24. If the shower base is not level, a mortar base or a polyurethane-type construction adhesive may be used. **DO NOT USE CONCRETE.** Regardless of the chosen leveling compound for the shower base, it is essential that the entire bottom surface of the base makes contact with the compound.



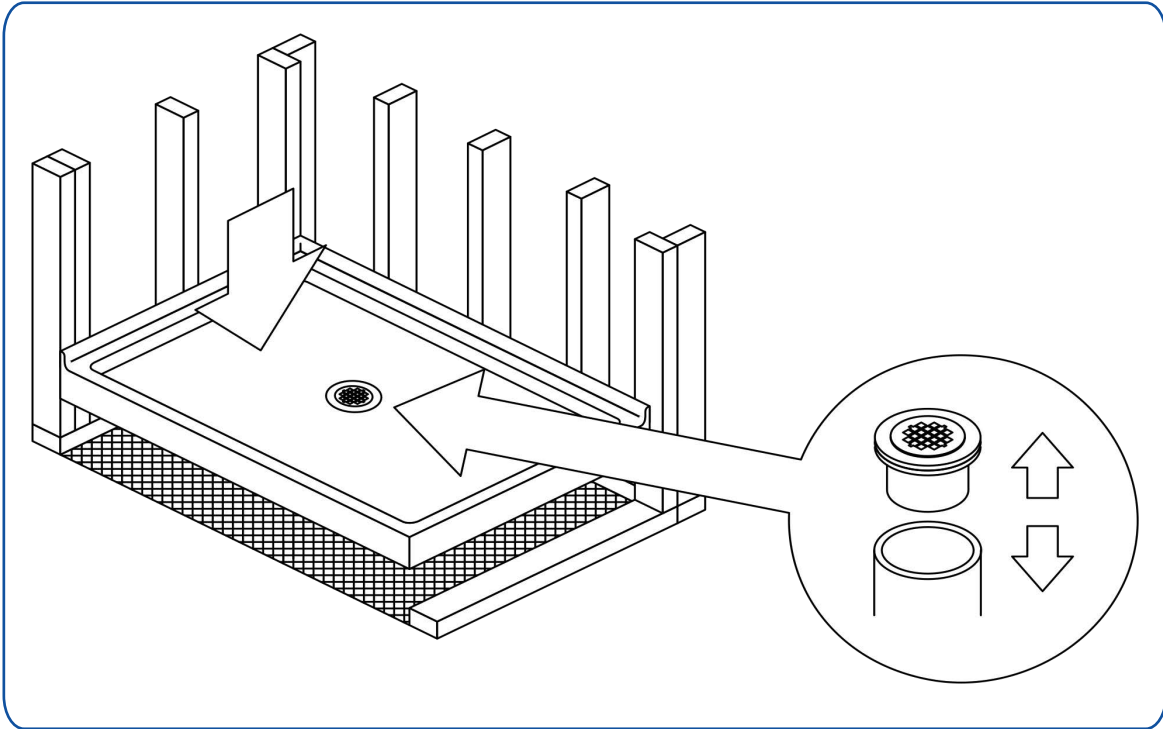
25. If applying a mortar bed, we recommend a thickness of 1" – 1 ½". The thickness of the material will fluctuate depending on the floor's condition and the degree of irregularity on its surface. We suggest placing a **THIN POLYETHYLENE SHEET**, approximately 1/16" or 2mm thick, over the mortar to prevent the shower base from becoming permanently adhered to it.



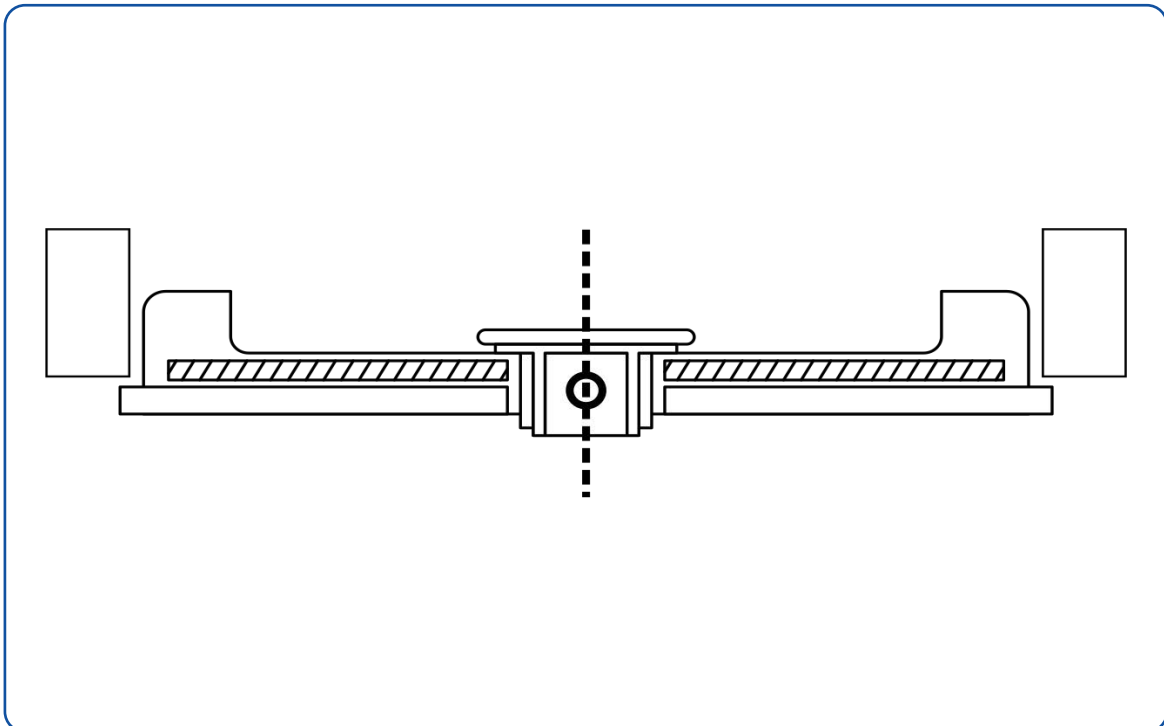
26. Ensure that the mortar bed is spread evenly throughout the installation area using a mortar base. Make sure to avoid any contact between the mortar and the drain during the installation process. Avoid applying mortar within a 5-inch radius of the drain area.



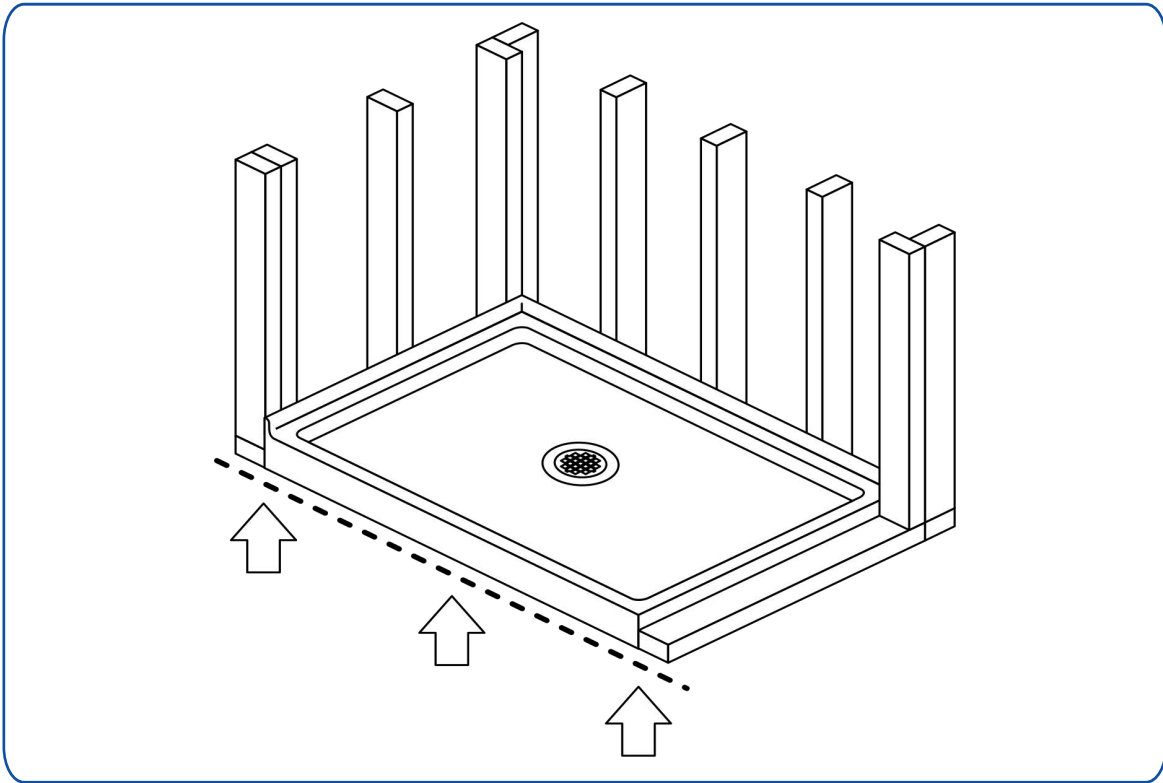
27. Once the bedding material has been poured and before it sets, place the shower base into the installation space, ensuring the drain assembly slides over the waste pipe. Press and level the base into the bedding material.



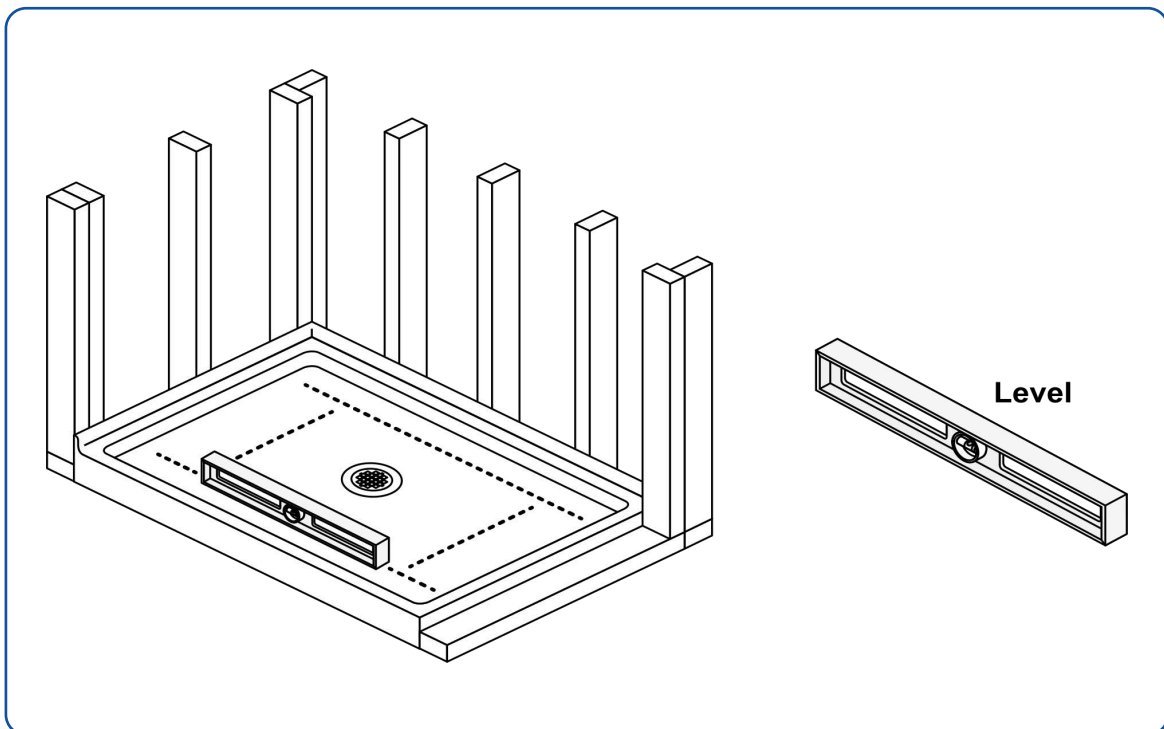
28. Center the base in the installation location.



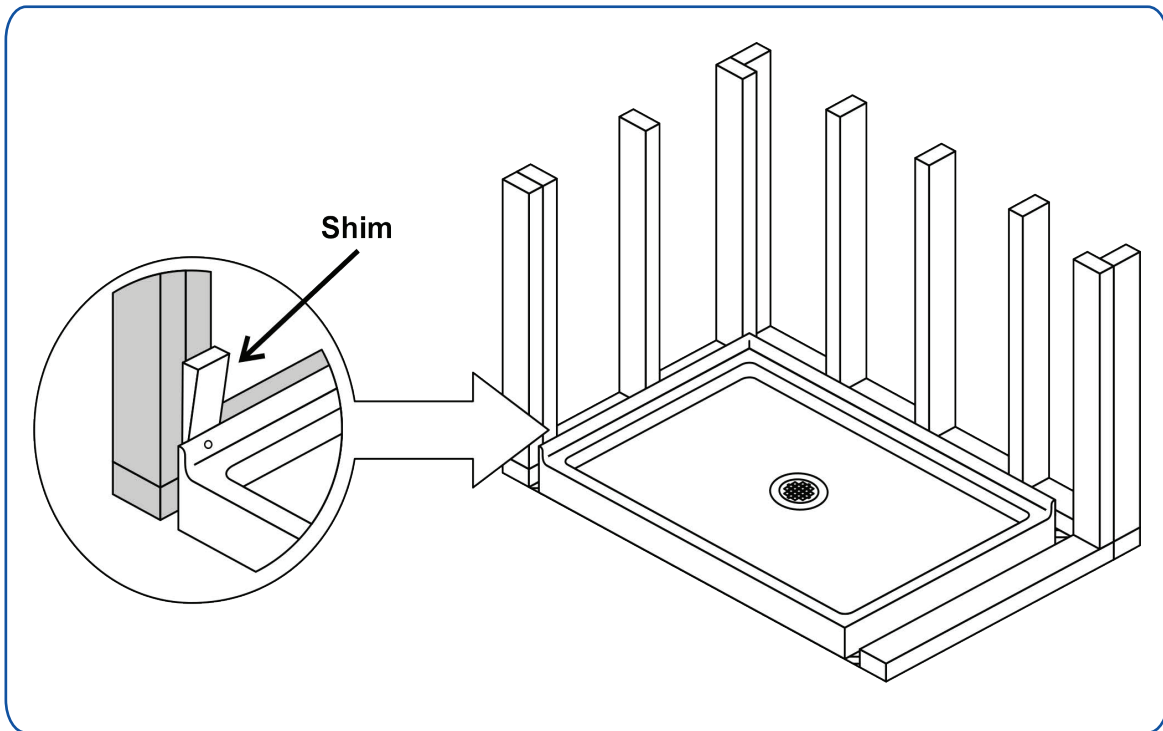
29. Ensure that the front of the base is in complete contact with the floor along the entire length of the shower base.



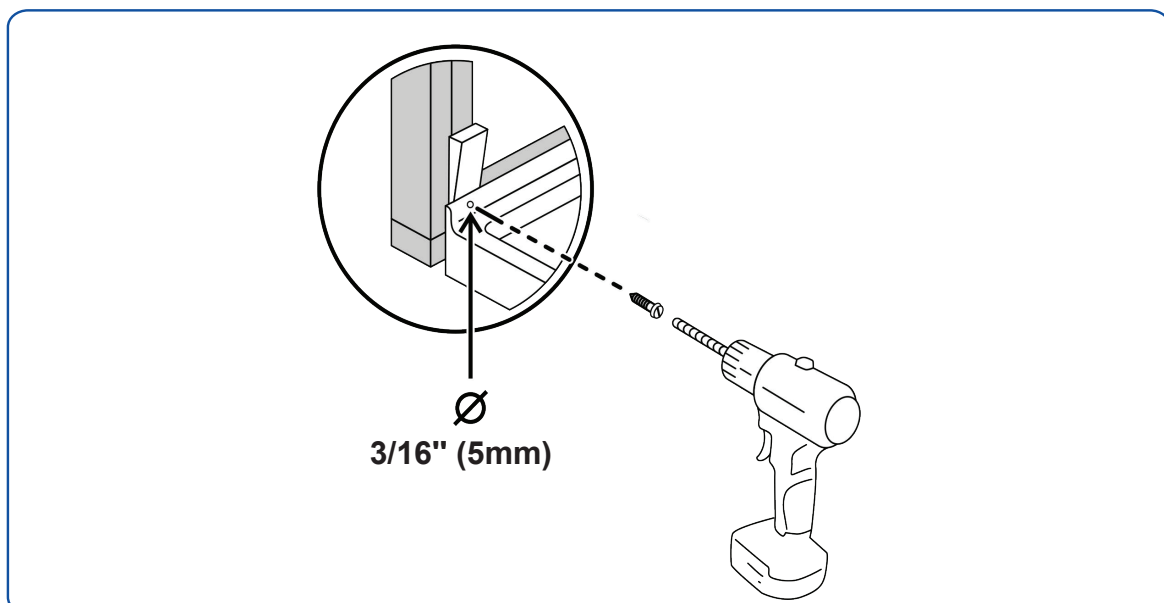
30. Re-check to make sure that the shower base is level.



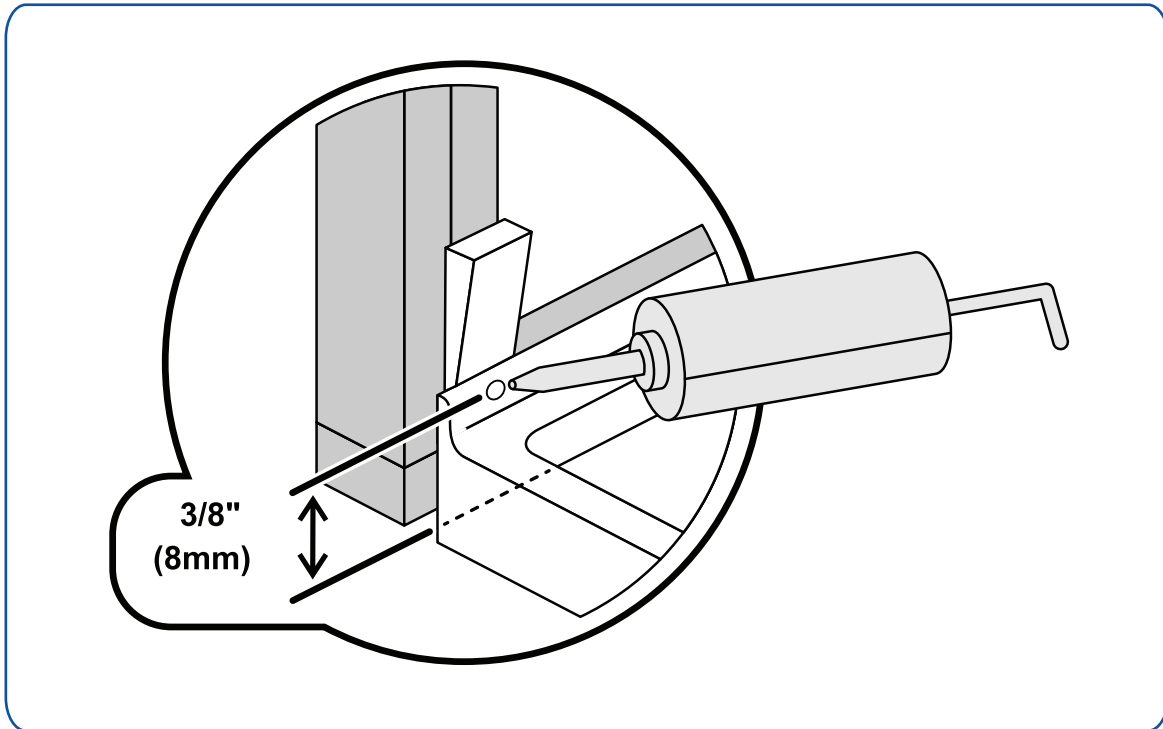
31. If the alcove is larger than the shower base, use shims or furring strips between the base and studs to ensure a snug fit. Please ensure the gaps between the flanges and stud are smaller than 1/8" after shimming.



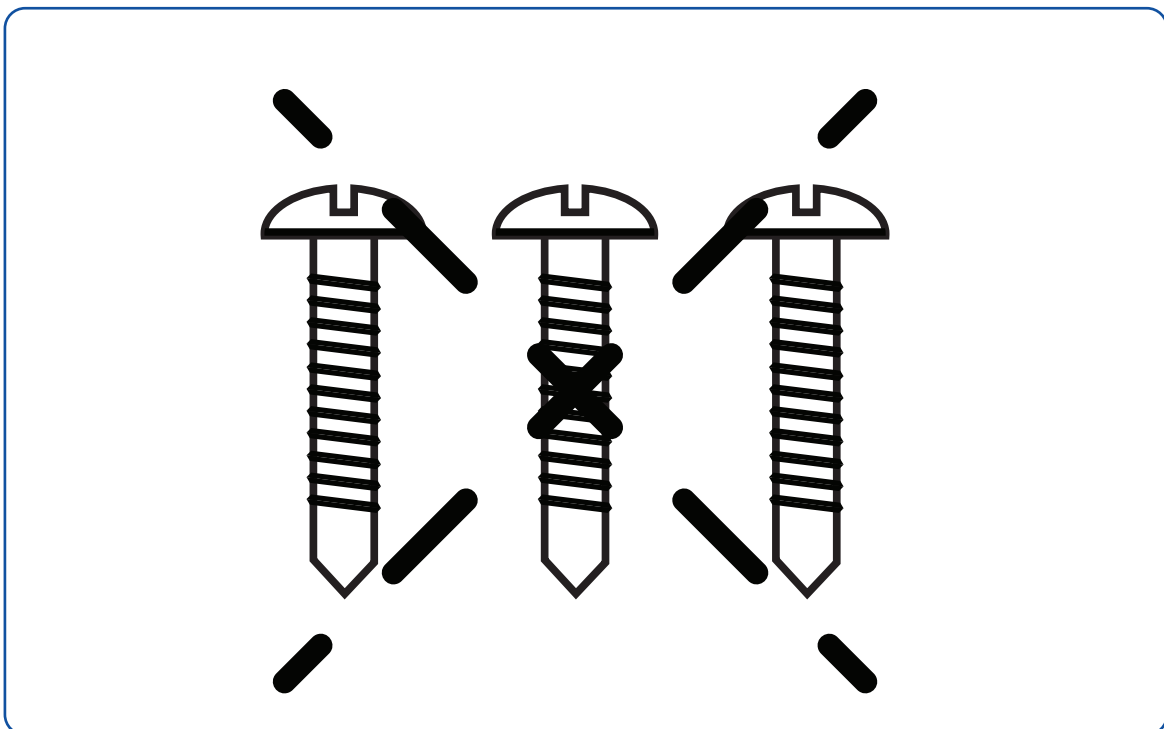
32. To avoid causing damage to the shower base, it is recommended to use a 3/16" (5mm) drill bit for pre-drilling holes in the flanges when securing them to the studs. Make sure to drill holes in the flange only from the inside. Avoid pre-drilling the studs and refrain from directly drilling holes into them.



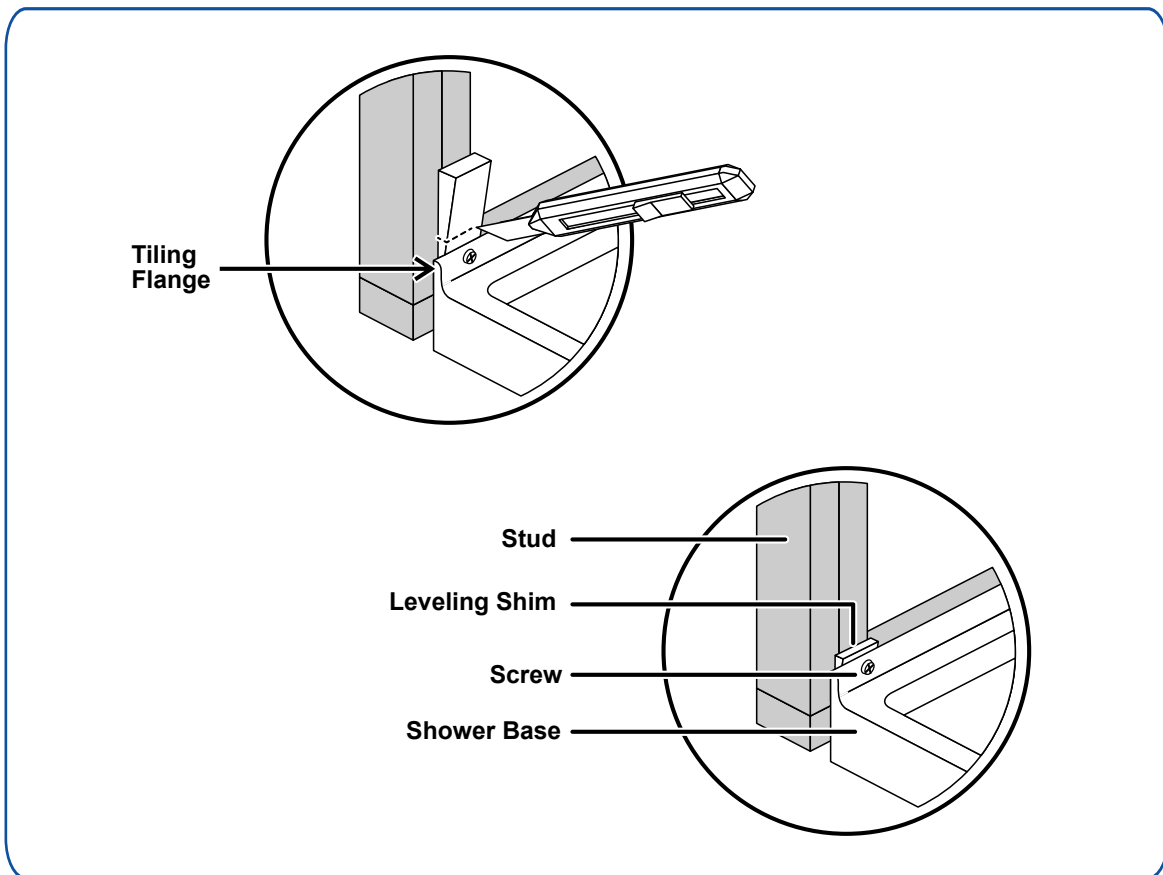
33. Ensure that the bottom of all holes in the flange is positioned at least 3/8"(8mm) above the base threshold. Before tightening, it is crucial to fill these holes with silicone.



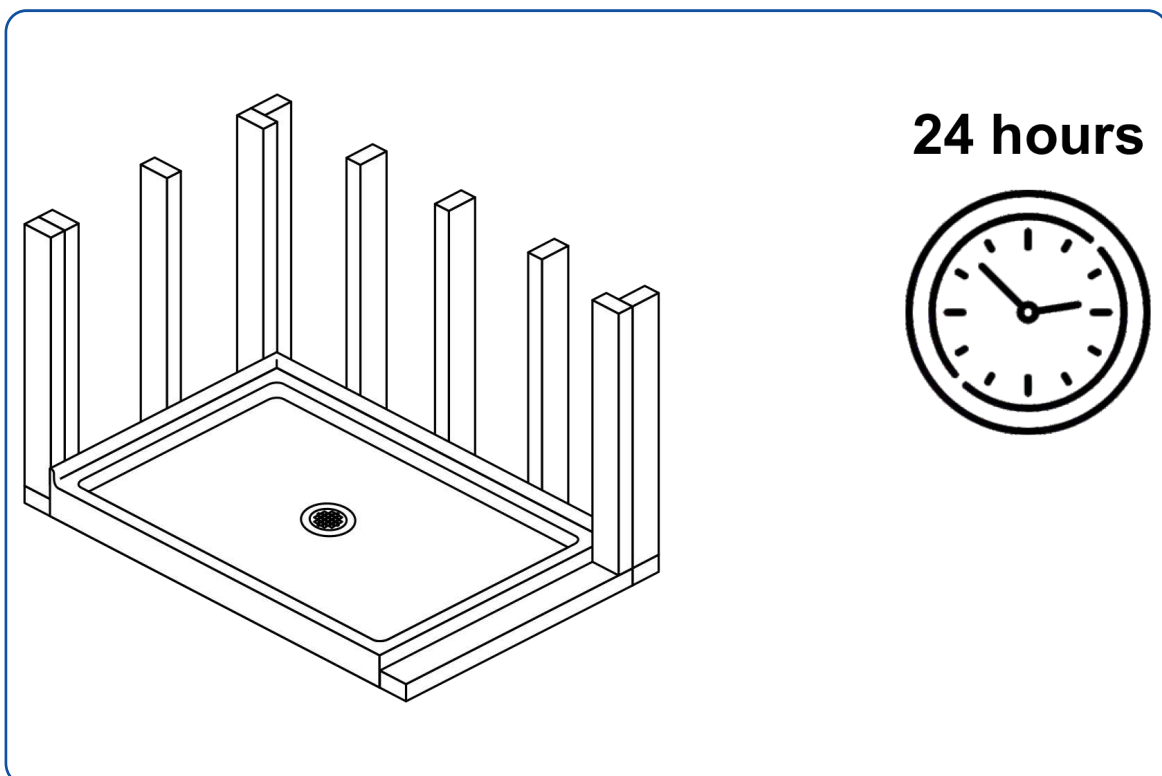
34. Do not use drywall screws to secure flanges to wall studs. Product damage will occur and will void the warranty.



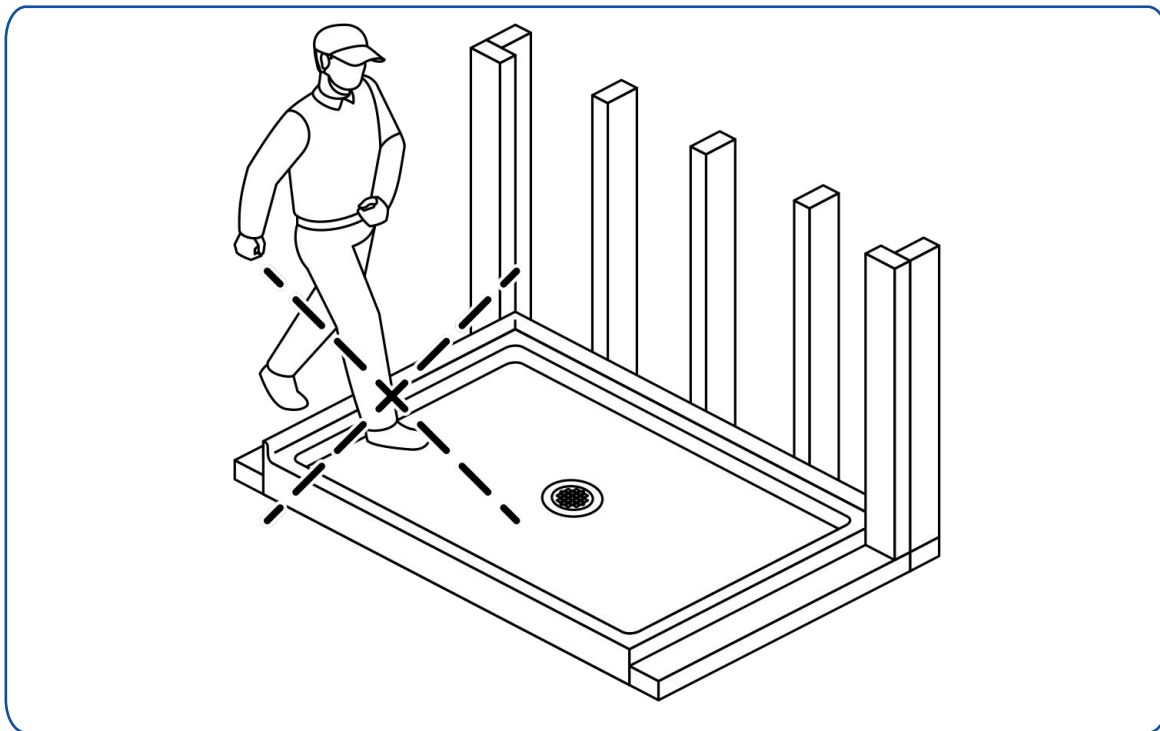
35. After securing the flange to the studs, trim off any excess wood from the shims.



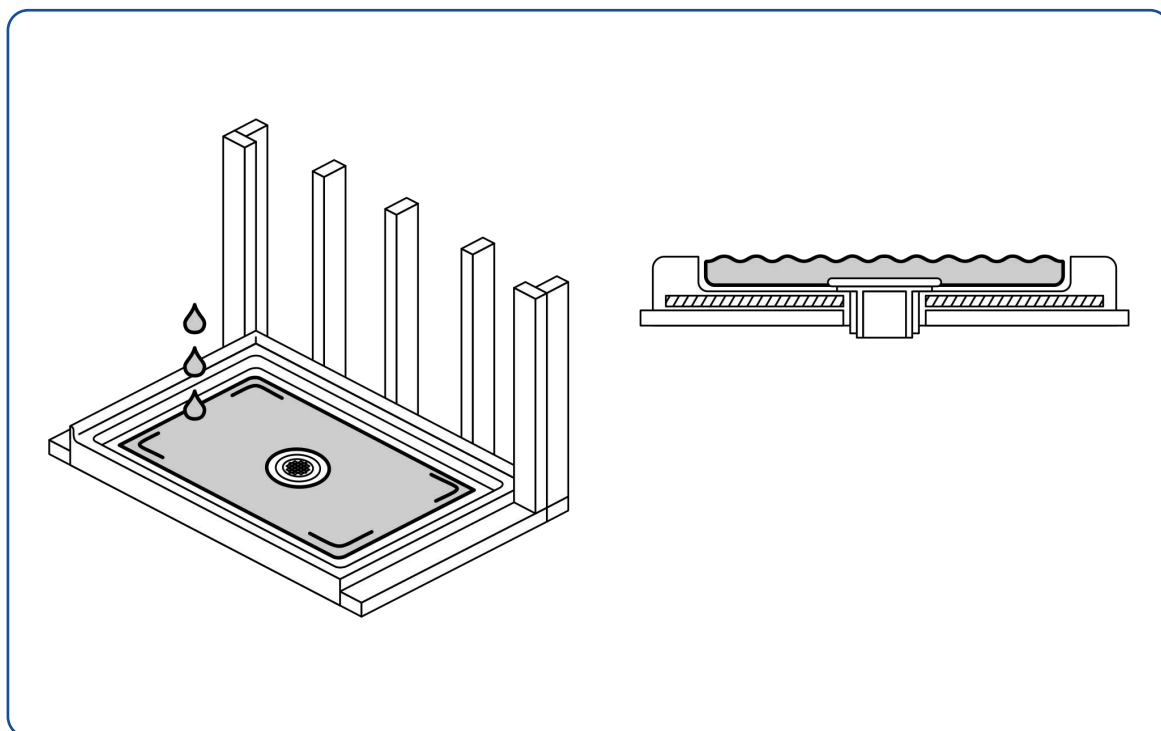
36. You should allow the mortar bed to settle for a period of 24 hours before proceeding with any additional work.



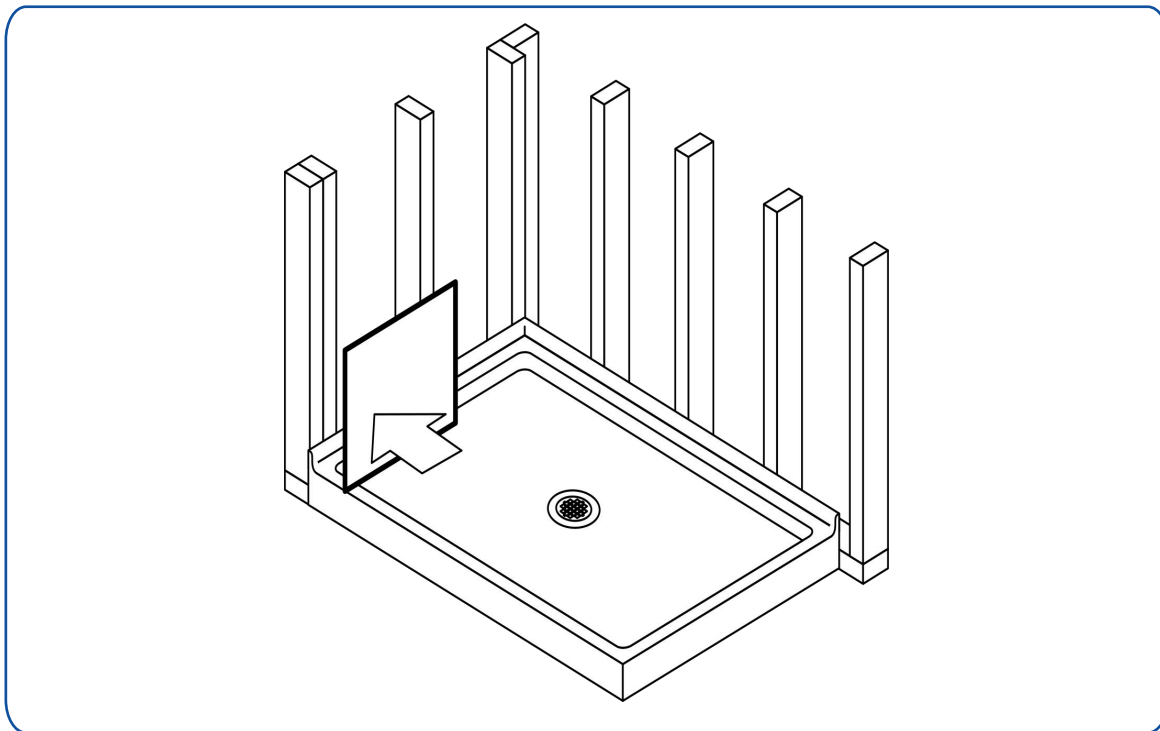
37. Wait until the bedding material is entirely hardened before placing any weight on the bottom of the shower base.



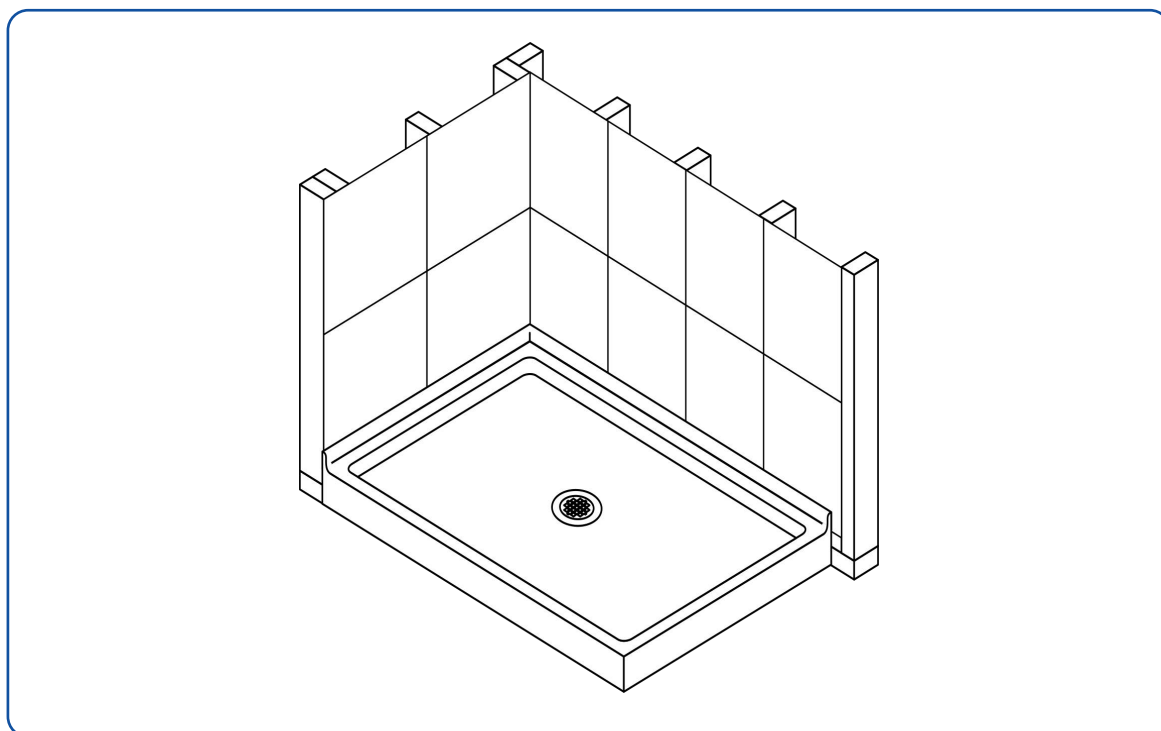
38. Conduct a water test of the drain and plumbing to ensure there are no leaks.



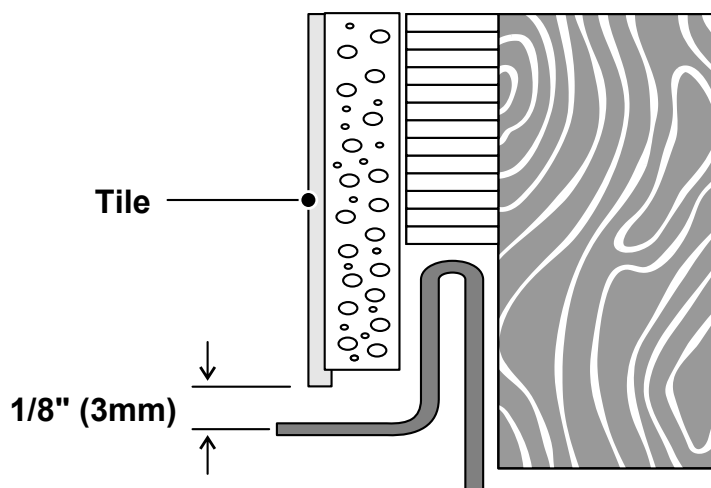
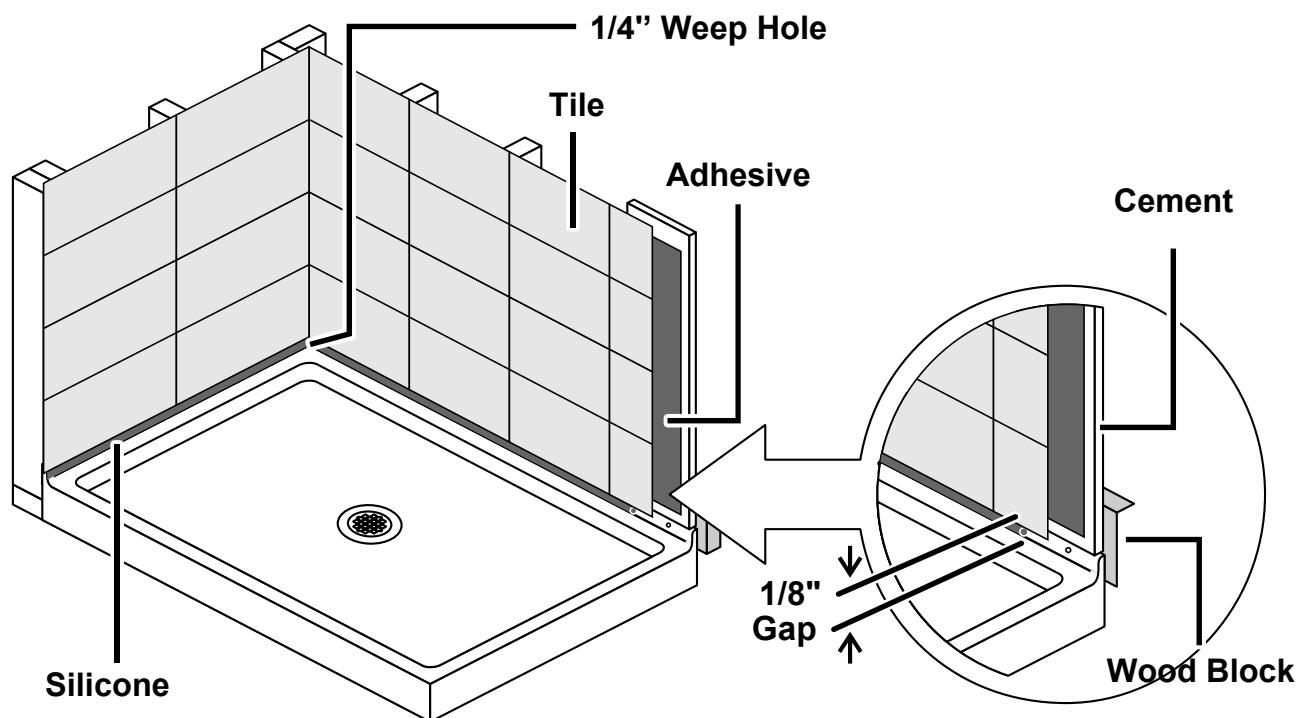
39. Follow the appropriate local plumbing code and guidelines to install the drywall.



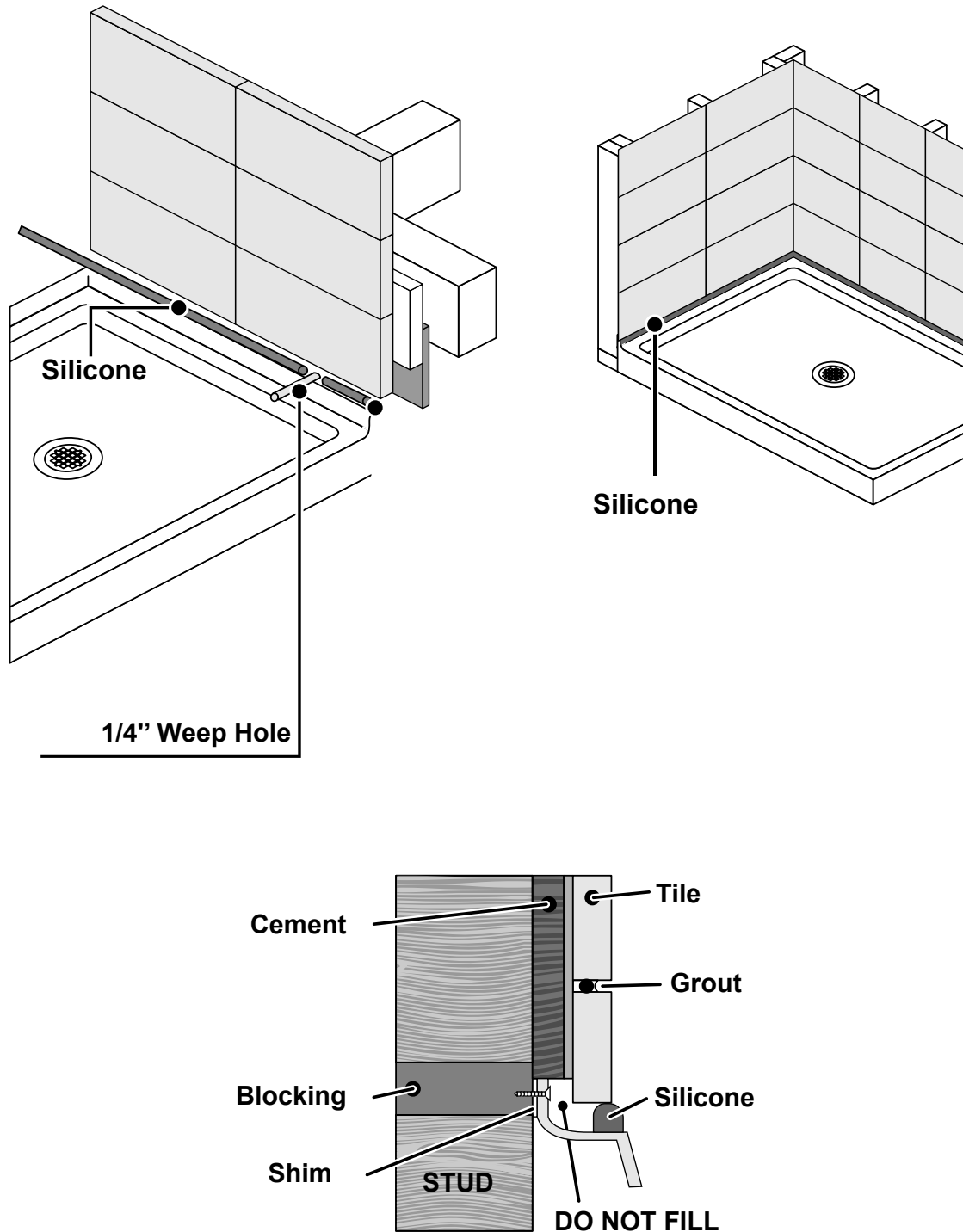
40. Apply the drywall and tile or alternative material to the walls and/or floor according to the manufacturer's instructions.



41. Leave a 1/8" gap (3mm) between the finished material and the lip of the flange. Use 100% silicone to caulk and seal the gap.



42. Leave a minimum 1/4"-1" weep hole at the back and front corners of the shower base. Weep holes serve the purpose of enabling drainage for any leakage that may occur through unsealed tiled grout. **DO NOT FILL THE HOLES.** By filling it, you will effectively hinder the drainage of moisture back to the base through the weep holes.



Product Care

- To eliminate soap residue and mineral deposits from the surface of the shower base, use warm water, a soft sponge and a mild liquid detergent or non-abrasive cleaner.
- Do not use abrasive cleaners, scrapers, metal brushes, or anything that might scratch or dull the surface.
- Avoid using harsh chemicals on the surface of the shower base.
- Prevent the surface from encountering products like acetone, dry cleaning solution, lacquer thinners, and other similar substances.
- Refrain from using razor blades or other sharp tools that could cause scratches on the surface
- Avoid using aromatic solvents.
- If the grout or caulking in your shower crumbles where the walls meet the tub or shower floor, reapply the caulking as soon as possible to avoid water damage.
- If a rubber mat is utilized on the shower base, it must be removed immediately after each use.
- For tougher-to-reach places, we recommend using a soft-bristled brush to scrub in between these areas.
- It is not advisable to apply wax to areas where you frequently walk or stand.



Scratch Removal

- To eliminate minor scratches, apply a thin layer of automotive paste wax and lightly buff the affected area with a clean cloth.
- To address small scratches, use wet/dry sandpaper with a 600-grit rating to lightly sand the surface.
- For repairing deep scratches on your shower base, opt for higher-grit sandpaper, such as 1,500-grit wet/dry sandpaper. Start by moistening the sandpaper, and then use gentle circular movements to rub it over the affected area until the scratches vanish. Make sure to sand the surrounding area as well to blend the repair seamlessly and achieve an even surface.
- After sanding, use a towel to wipe away any dust from the sandpaper and dry the surface. Then, apply a quarter-size amount of automotive polishing compound onto a separate washcloth. Rub the compound gently in circular motions over the shower pan until the sanded surface shines and no residue of the compound remains.



Smoothing Dull Areas

- To tackle any dull areas, grab a clean washcloth and put a quarter-sized amount of metal polish on it.
- Utilize circular motions to gently rub the polish over the scratched or dull parts of the shower pan. Keep polishing the surface with the metal polish until the dull areas transform into a shiny finish.

Stain Removal

- Mix one cup of water and one cup of vinegar together, then add two tablespoons of baking soda. Transfer the solution into a spray bottle and adjust the concentration by adding additional water if needed. Spray the affected area and let the solution sit for five to seven minutes.
- For stubborn stains, directly apply a tablespoon of baking soda onto the stain and use a soft-bristled brush or disposable toothbrush to scrub it away. After cleaning the entire shower base, rinse it thoroughly with water.
