Installation Steps

- Take out the table lamp and insert the power cord into the power hole of the lamp body;
- 2. Click the power button to turn on the desk lamp.



Recommended Height : 40cm

Instructions

- 1. Touch the touch switch to turn on the desk lamp;
- 2.When the desk lamp is on, the brightness of the main lamp changes from the current state every time it is touched. The sequence of <15% --- 50% --- 100% --- off> switches back one gear in turn,Multiple
- touches follow this cycle, and the brightness is switched without buffering; 3. The lamp is off when the power is first applied;
- 4. The lamp has a power-off memory function, such as when the power is off or unplugged, the lamp is in the brightest state, After the power is turned on, the lamp is still in the brightest state;



Safety Precautions

- Make sure that the adapter is an original adapter before use, if you use a nonoriginal adapter, it may damage the product and bring security risks;
- The led light source module is not replaceable. Do not disassemble the product without permission. When the light source reaches the end of its life, the entire lamp should be replaced;
- The desk lamp generates heat during work, please keep the surrounding air convection for heat dissipation;
- It is strictly forbidden to enter the product into water or work under the conditions of exceeding the temperature and humidity;
- Don't put your fingers between the light arm connecting rods when adjusting the angle, so as not to hurt your fingers.
