


Urban Oak Full Bed


Assembly Instructions

Step 1

Footboard


Insert 1 wooden dowel (G) into the hole on Part 15 and insert 2 wooden dowels (F) into the holes on Part 8. Attach Part 15 to Part 8 with 2 screws (I), using Phillips Screwdriver. NOTE: Wooden dowels should only be inserted halfway into holes.



Step 2

Footboard

Attach Part 3 and 4 to Part 8 with 4 bolts (A), using 4 half moon nuts (E) and Allen wrench (K)




Step 3

Headboard

Insert 1 wooden dowel (G) into the hole on Part 15 and insert 2 wooden dowels (F) into the holes on Part 7. Attach Part 15 to Part 7 with 2 screws (I), using Phillips Screwdriver. NOTE: Wooden dowels should only be inserted halfway into holes.





Headboard

Insert 6 wooden dowels (F) into the holes on Parts 5 and 6. NOTE: Wooden dowels should only be inserted halfway into holes.




Attach Part 5 and 6 to Part 2 with 3 bolts (B), using Allen wrench (K).


Headboard

Attach Part 5 and 6 to Part 1 with 3 bolts (B), using Allen wrench (K).

Attach Part 7 to Part 1 with 1 bolt (A), using half moon nut (E) and Allen wrench (K).


Step 8

Siderails


Insert 2 wooden dowels (F) into the holes on Part 9.

Attach Part 9 and 10 to Part 11 with 4 bolts (D), and 4 nuts (J) using 2 Allen wrenches (K).





Step 9 Siderails Attach Siderails to Headboard with 2 bolts (A), and 2 half moon nuts (E) using Allen wrench (K). PLEASE ASSEMILE BED IN THE GROUND, BUT FIRST PLACE SOME PROTECTIVE MATERIAL, SUCH AS A RUG OR CARDBOARD BOX, ON PLOOR TO PREVENT ANY DAMAGE TO THE BED. MANUFACTURER LABEL DO NOT REMOVE!






MAINTENANCE:

- Our furniture is designed to be low maintenance, however misuse, irregular use, or improper assembly can result in product malfunction. Regularly check the stability. If pieces feel loose or wobbly tighten all screws immediately and/or retie strings of tent cover.
- To store, review Assembly Instructions and reverse the steps to disassemble.
- Use only provided hardware to assemble and maintain assembly.

CARE:

- To clean use a soft, lint free rag similar to a cloth diaper and wipe away dust regularly.

 If necessary dampen cloth slightly with warm water and gently rub away spots. Dry thoroughly.
 - · Do not use a bleach solution.
 - Do not submerse or allow to lie in standing water.
 - Do not use a sponge or harsh abrasive.
 - Do not use all purpose cleaners or harsh detergents.
 - Do not use Pine Oil cleaners or abrasive household cleaners.
 - · Do not use heat or hot water.
