





### Step 1

#### Headboard


Insert 12 wooden dowels (A) into the holes on to parts 9, 11 and 14 as shown in the diagram.

#### Headboard


Attach parts 8, 9, and 11 on to part 2 with 3 bolts (C), using 1 Allen wrench (I). Attach part 14 on to part 2 with 1 bolt (B) and 1 half moon (G), using 1 Allen wrench (F).

#### Headboard


Attach parts 8, 9, and 11 on to part 1 with 3 bolts (C), using 1 Allen wrench (F). Attach part 14 on to part 1 with 1 bolt (B) and 1 half moon (G), using 1 Allen wrench (F).



### Step 4

#### Footboard


Insert 8 wooden dowels (A) into the holes on to parts 5 and 7 as shown in the diagram.


#### Footboard

Attach parts 5 and 6 on to part 7. as shown in the diagram.





### Step 9

#### **Siderails**


Attach part 15 on to Headboard and Footboard with 4 bolts (B) and 4 half moon (G), using 1 Allen wrench (F).



### Step 10

#### **Bed Slats**


Attach the slats 13 on the part 12 with 2 bolts (D), using 1 Allen wrench (F).



### Step 11

#### **Bed Slats**


- 1) Attached the first slat to the end of the side rail base with 2 screws (E), using a phillips screwdriver.
- 2) Use the spacer (H) to limit the space between the slats.
- 3) Attach the slats 10 and 13 with 24 screws (E), using a phillips screwdriver.
- 4) Please note warping may occur because it is natural wood. To facilite the placement of the screws, you must press the two siderails simultaneously.



Option 1 Assembly with Trundle








#### **MAINTENANCE:**
