- CUP:** PAINTED STEEL, 20.3 CM (8") DIA. x 2.5 CM (1") HEIGHT.

- COLUMNS:** PAINTED STEEL, 5 CM (2") DIA. x 3 CM (1-3/16") HEIGHT.

- POLES:** PAINTED STEEL, 3.2 CM (1-1/4") DIA. x 39.1 CM (15-3/8") LENGTH. (3) POLES PROVIDED.

- BASE:** PAINTED STEEL, 28.5 CM (11-1/4") DIA. x 3 CM (1-3/16") HEIGHT.

- CORD:** UL APPROVED FOR WET LOCATION, MIN 305 CM (10 FT.) LENGTH, 18 AWG., 3 CONDUCTORS, 105°C, TYPE SJTW, WATER PROOF. BLACK COLOR, COPPER MATERIAL. WIRES MUST BE LEAD FREE.

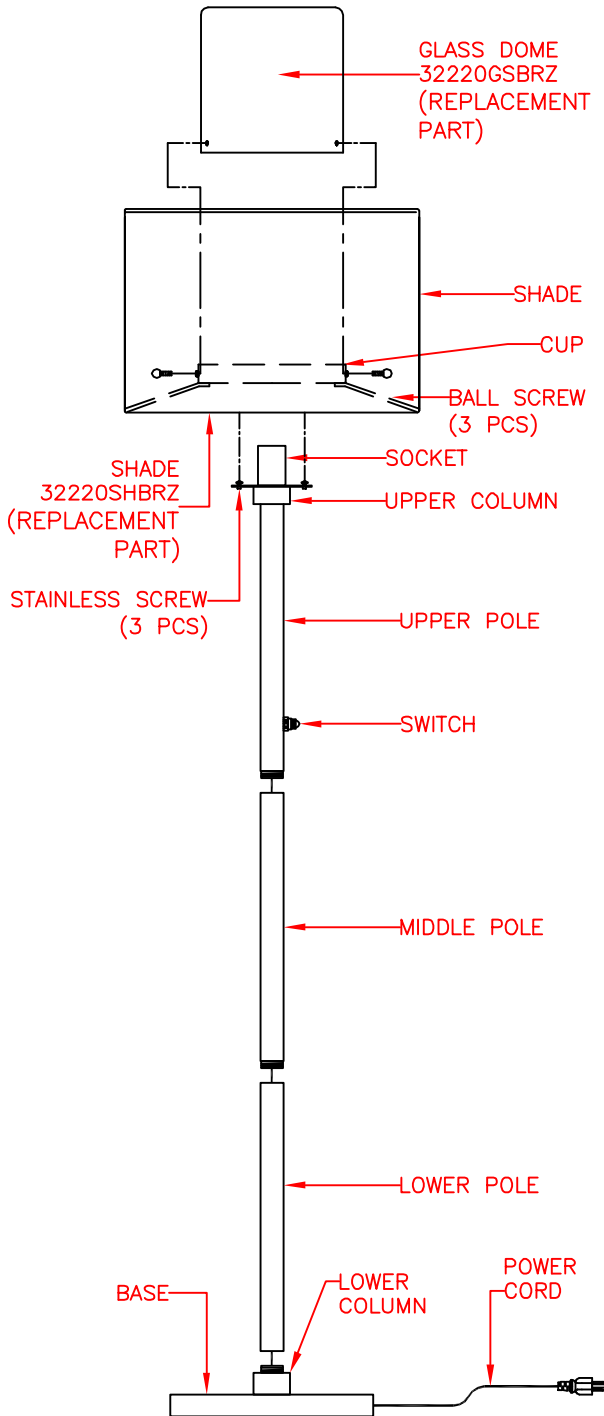
- LABELS:** UL AND CSA OR CUL, MANUFACTURING DATE, MODEL # AND COUNTRY OF ORIGIN LABEL PROVIDED. RELAMPING LABEL FOR 100 WATT MAX. TYPE "A" BULB PROVIDED NEAR SOCKET.

### PACKAGING AND SHIPPING DETAILS

- THE LAMP IS DISASSEMBLED FOR SHIPPING. EACH PART IS CAREFULLY WRAPPED IN A PLASTIC BAG AND PLACED SECURELY IN THE INNER PACKING SO IT CAN NOT MOVE AROUND DURING SHIPPING. A SMALL BAG OF SILICA IS INCLUDED IN THE PACKAGE.
- THE CARTON IS MADE OF DOUBLE WALL, CORRUGATED CARDBOARD "A MA A". BROWN IN COLOR. THE INNER PACKING IS DIE-CUT CARDBOARD OR STYROFOAM TO PROTECT AND SECURE THE LAMP AND MUST PASS THE FEDEX AND ISTA-3A DROP TEST REQUIREMENTS.
- EACH CARTON SHALL BE PRINTED WITH A LINE DRAWING AND THE KENROY HOME NAME AND LOGO, MODEL NUMBER AND FINISH, EACH CARTON SHALL BE PROVIDED A UPC LABEL. THE UPC BAR CODE AS FOLLOWS: BRZ=053392005467.

- MODEL 32220BRZ INSTRUCTIONS ARE TO BE PACKED WITH EACH LAMP. INSTRUCTIONS MUST BE PRINTED CLEARLY ON QUALITY PAPER.
- ALL VISIBLE METAL PARTS MUST MATCH LAMP FINISH UNLESS OTHERWISE SPECIFIED.
- ALL BAGS MUST BE LABELED WITH OFFICIAL "THIS BAG IS NOT A TOY" STATEMENT.
- LAMP MUST REST FLAT ON SURFACE AND NOT ROCK. LAMP MUST PASS 12° TILT TEST.
- ASSEMBLY TIME: 10 MINUTES.
- THIS ITEM MUST BE UL APPROVED FOR WET LOCATION,
