


## **ASSEMBLY INSTRUCTIONS**

#### STEP 1


Screw FEET LEVELERS (H) into the bottoms of each BOTTOM SIDE FRAME (B). Turn clockwise to screw in place.






#### STEP 2

Connect TOP SIDE FRAME (A) to BOTTOM SIDE FRAME (B). Using the included HEX KEY (I), screw 1 FRAME CONNECTING SCREW (F) into each hole where BOTTOM SIDE FRAME (B) is connected with TOP SIDE FRAME (A). Repeat for remaining FRAME CONNECTING SCREWS (F).






## **ASSEMBLY INSTRUCTIONS**


#### STEP 3

Lay SIDE FRAMES (TOP + BOTTOM SIDE FRAMES assembled in Step 2) on its side.



Place FIXED SHELVES (C) on their sides and connect them to TOP & BOTTOM SIDE FRAMES (A & B). Tighten SCREWS (E) with HEX KEY (I).

Stand the unit upright.




#### STEP 4

Tighten 4 ADJUSTABLE SHELF RESTS (G) into shelf frame by hand and make sure they are on the same level.

Do the same for the other 4 ADJUSTABLE SHELF RESTS (G).

Place 2 ADJUSTABLE SHELVES (D) on each set of ADJUSTABLE SHELF RESTS (G). Make sure the shelf notches are resting on ADJUSTABLE SHELF RESTS (G).



## **ASSEMBLY INSTRUCTIONS**

#### STEP 5


To install the ANTI-TIPPING KIT (J), place 4-Tier Bamboo Shelving against the wall. Mount bracket to the wall, next to outer TOP SIDE FRAME (A) just below the top FIXED SHELF (C).


First, fully secure ANTI-TIPPING KIT (J) to the wall.

Next, close cable loop through TOP SIDE FRAME (A) as shown.






## **PRODUCT EXTRA SHELF OPTIONS**



## TRINITY 4-Tier 15" x 20" x 72" Bamboo Shelving Model # TBFPRA-2703

Trinity International Industries ("Trinity") warrants to the original consumer purchaser ("Purchaser") of the TRINITY 4-Tier 15" x 20" x 72" Bamboo Shelving ("Product") that each Product shall be free from defects in workmanship and materials for a period of 1 year from the date of original purchase. Trinity's obligation under this warranty shall be limited to repair or replacement of, or adequate compensation for the Product which shall not be greater than the amount of the purchase price of the Product, at the option of Trinity, during the warranty period. All replaced parts and Products become the property of Trinity and must be returned to Trinity.

This warranty excludes normal wear and tear of the Product and its parts or components, and damage arising from any of the following: negligent use or misuse of the Product, use contrary to this User's Manual, or alteration by anyone other than Trinity. The warranty period of 1 year shall not be extended or renewed by the repair or replacement of, or compensation for, the Product.
