


# STOP!

\* Insert Fifteen KD BOLT (1) to the TOP PANEL (A) and Two CURVED PANEL(F)




\* Insert Ten KD BOLT (1) to the LEFT PANEL (C) and RIGHT PANEL(D).

\* Insert Four KD BOLT (1) to the both side of BETWEEN PANEL (B).






\* Insert Two KD BOLT (1) to the LOWER BACK PANEL (E).


\* Attach the Two METAL PLATE(17) to the LEFT PANEL (C) and RIGHT PANEL(D) by the SCREW (11).



- \* Assemble the DRAWER SUPPORT PANEL (N) to the DRAWER TRAY by the SCREW (11) .








### Step 17:

\*Input Six Drawer tray to the stand.





#### Step 23:


1st- With your pencil, strike a mark through the center of the hole in the SAFETY STRAP.

2nd- Drill a 3/8" hole on the mark.

3rd- FURNITURE TIPPING RESTRAINT KIT (9) into the hole until it is even with the surface of the wall.

4th- Turn the LONG SCREW through the hole in the SAFETY STRAP and into the WALL ANCHOR.

NOTE: You will need to turn the LONG SCREW multiple turns to completely tighten
